BOARD OF HEALTH MEETING RESULTS Tuesday, May 22, 2007 at 3:00 PM Town Hall, Hearing Room 367 Main Street, Hyannis, MA

Ι. Hearing:

Tobacco violations as reported by Bob Collette of Barnstable County Tobacco Control.

A. Show Cause Hearing:

7-11 Store No. 25161B, 210 North Street, Hyannis – Second Offense, tobacco products sold to a minor.

The Board voted to issue a \$100 fine for the second offense. (Unanimously voted in favor.)

B. Hearing:

Sea Street Market, 231 Sea Street, Hyannis – First Offense, tobacco products sold to a minor.

Jennifer Cullen, owner, asked for a change in procedure. Bob Collette will do a guick version of the report and leave the form at the time of inspection for the manager.

The Board voted to issue a warning. (Unanimously voted in favor.)

П. Hearing: CONTINUED WITH Charles Hamblin, owner - 1726 Santuit-Newtown Road, Cotuit, NO FINDING UNTIL applicant is requesting permission to accept grass and leaves OCT 9, 2007 at premises.

 A. Arlene Wilson, A.M. Wilson Associates representing Elaine Robin, Trustee, Robin Family Realty Trust – 386 Shootflying Hill Road, Centerville, 2.1 acre lot – two variances from setback of 100 feet from wetland (BVW). The Board voted to approve the variances with the condition of using a monolithic tank.

The Board voted to approve variances with the following conditions: 1) a four (4) bedroom deed restriction, 2) an I/A system, and 3) quarterly monitoring plan for two years then come back to the Board for review of monitoring plan. (Dr. Canniff abstained.)

VI. Food Establishment Variance Requests (New):

GRANTED A. Caffe Gelateria Bertini, 20 Pearl Street, Hyannis, grease trap variance. **WITH CONDITION**

As a new establishment, the touchless faucets are required. The Board voted to approve the under sink grease trap, size to be determined by the Town of Barnstable Plumbing Inspector, and limited to the submitted menu.

GRANTED B. Roger Ghanem, Craigville Beach Grill, 974 Craigville Beach Road, **ONE, DENIED ONE,** Centerville, three variances and Outdoor Dining Application. **ONE VARIANCE REQUEST IS NOT APPLICABLE.**

The Board voted to approve the variance of one toilet facility. The Board voted to deny the variance request of no concrete slab under the dumpster as it is a federal rule to have impervious material under the dumpster. The variance request for an air curtain is not applicable at this location.

VII. Variance Renewal – Smoking

GRANTED David Wood, Puff the Magic, 649 Main Street, Hyannis, variance renewal FOR – Section 2.0 Prohibition of smoking regulations, pre-existing smoking bar TWO YEARS

The Board voted to approve the renewal for the pre-existing smoking bar for a period of two years to run May 1, 2007 – May 22, 2009. The applicant did request a renewal for a 10 year period. The Board agreed to take it under advisement. They will check with the Town Attorney who was involved in the initial time period of two years and will review with the Town Attorney the option to transfer variance with ownership. If the Town Attorney agrees with these two items, the Board will adjust the decision without going in front of the Board again.

VIII. Body Art Applicant:

GRANTED Jackie Lynn Connolly – Application for Body Art to operate at Cape Cod Tattoo at 701 Main Street, Hyannis.

The Board approved Jackie Lynn Connolly for a Body Art License.

IX. Lifeguard Modification Request:

GRANTED Jessica Maguire - Willy's West (Gym), 865 Attucks Lane, Hyannis.

The Board voted to Grant however, the Board requests all the CPR certificates be submitted to the health division. The Willy's West Gym's pool will be only for adults.

X. <u>Discussion:</u>

A. Cotuit Meadows Subdivision (a.k.a. Scrimshaw Village), 9999 Falmouth Road (Rte. 28), Cotuit. 50 acres.

The Board approves the plan which will be sent to DEP for application.

B. Dumpster Screening at pre-existing establishments– Cynthia Cole, Executive Director, Hyannis Main Street (BID).

The Board approved a six-month moritorium to the Nov 13, 2007, agenda. They will come back to the Board at that time with a definitive plan, (bids, time frame, etc.)

C. Percolation tests and soil evaluations for local upgrade approvals.

Options were submitted to reduce the amount of time waiting for a percolation test: the use of soil evaluators as witnesses, the use of other town's health inspectors on off hours, the use of our town's health inspectors during off hours and weekends for an additional fee, or the use of a sieve test in place of a percolation test. Title V allows the sieve test to be used if the findings fall within a certain parameter. The Board agreed to take these under advisement. If an additional fee was charges for overtime, the town would have to set up a separate account through Finance so the payroll does not come out of the regular payroll.

D. Request for permission to grant variances at counter for setbacks to property line, five feet or greater.

No. Not at this time unless it is an emergency repair. For emergency repairs, it can be approved and would come back before the Board. The State requires the Board to review these.

E. Peter Doyle, Town of Barnstable, Water Pollution Control Division – permission for herbicide application.

The Board granted permission for herbicide application for a five (5) year period.

F. Request to increase the percolation test fee to \$150 for night-time and weekend percolation.

The Board determined the \$ 150 proposed fee was too low to cover costs for such a project of working night-time and weekends, and will consider approval of a \$200 fee.

XI. Massage License Applicant:

The Board approved Kirsten Cahoon for a license as a massage therapist.
