 Approval of the Draft Community Preservation Committee Regular Meeting Minutes from January 22, 2024.

#### Letters of Intent:

- A Letter of Intent has been received from the Town of Barnstable Department of Public Works requesting \$750,000 in Community Preservation Historic Preservation funds for design and restoration of the West Barnstable Railroad Depot. Proposed restoration work will include removal and salvage of the existing clay tile roof; repair of deteriorated roof sheathing; waterproofing and reinstallation of the historic roof tiles; repairs to the existing windows; building trim; interior ceiling repair and associated elements as funding allows. The building is located within the Old Kings Highway Historic District and the West Barnstable Historic District. It is listed as a Massachusetts Cultural Resource and a contributing building to the National Historic District. The building currently houses the Cape Cod Chapter of the National Railway Historical Society. Estimation of project completion is Summer of 2026.
- A Letter of Intent has been received from the Town of Barnstable Department of Public Works requesting \$2,940,000 in Community Preservation Historic Preservation funds for the exterior restoration of the Hyannis Armory. Proposed restoration work includes exterior masonry restoration; window and door replacement; and flat roof replacement. The building is located in the Hyannis Waterfront Historic District and is individually listed as a cultural resource with the Massachusetts Historical Commission. The- building was designed by Cape Cod Architect, Walter M. Gaffney, and constructed in 1958 and housed training facilities, storage, and administrative offices for the National Guard. The Hyannis Armory rose to national prominence during the presidential campaign of John F. Kennedy when he made his acceptance speech at the Armory on November 9, 1960.
- A Letter of Intent has been received from the Town of Barnstable Department of Public Works requesting \$568,000 in Community Preservation Open Space/Recreation funds for creation of a new ball field/practice field at the Centerville Recreation Building property. The project will create a new 60-foot base line grass infield, backstop, fence, benches, retaining wall, storage shed, and irrigation system. The design of the new field will be coordinated with the new playground and parking area. Estimation of project completion is Fall of 2025.
- A Letter of Intent has been received from the Town of Barnstable Department of Public Works requesting \$600,000 in Community Preservation Open Space/Recreation funds for improvements to the Cotuit Memorial Park. The project will improve pedestrian access by bringing non-conforming walkways into compliance with ADA, replacing park benches, deteriorated flagpole, diseased trees, memorial relocation, and other site improvements. The Cotuit Civic Association has requested the rejuvenation of the Cotuit Memorial Park that is the focal point for the village, connecting the library, waterfront playground and provides support for local events and activities. Estimation of project completion is Spring of 2026.
- A Letter of Intent has been received from the Town of Barnstable Department of Public Works requesting \$2,100,000 in Community Preservation Historic Preservation funds for the design and restoration of the John F. Kennedy Memorial in Hyannis. The revitalization of the memorial is a project of critical importance and strong justification. The project aligns with the Town of Barnstable's commitment to preservice historical landmarks and ensuring that they remain vibrant and relevant for future generations. This historic landmark was constructed as a tribute to President John F. Kennedy and his connection to Cape Cod and is a tourist attraction and community gathering space. By restoring and modernizing the memorial park, an appealing, safe and accessible environment for all can be ensured. Estimation of project completion is Spring of 2026.

- Email from the Community Preservation Coalition DOR Announces November 2023 CPA Trust Fund Distributions.
  - It was noted and discussed that State Revenues are likely to be lower this year, as funds for the CPA Trust reflect the real estate market which has been slow.

#### **Project Updates:**

Chair Counsell provided the following updates:

- The Historical Society of Santuit and Cotuit's (HSSC) CPC Application for funds to preserve the WW II German POW Bottle was approved by the Town Council on November 16, 2023. A Grant Agreement is in the process of being executed.
- The Affordable Housing Growth & Development Trust's CPC Application for transfer of funds was approved by the Town Council on November 16, 2023.
  - It was noted that the AHGDT has applications under review for projects located at Yarmouth Road and Main Street, Hyannis.
- The Centerville-Osterville-Marstons Mills (COMM) Water District revised CPC Application was approved by the Town Council on December 7, 2023.
- The Mills Property, Mashpee Conservation Restriction (CR) to be granted to the Mass Division of Fish and Wildlife will be forwarded to the Open Space Committee and Conservation Commission for their recommendations to Town Council for final approval.
- The Wheeler Road Grant was awarded to the Town of Barnstable and was accepted by the Town Council on December 7, 2023.
  - It was noted that the award of the land grant will result in a large reimbursement to the Barnstable CPA fund.
- Cotuit and Santuit Historical Society building.
  - It was noted that the HVAC work has been completed and the project is nearing completion.
- Update on the CCRT Bikeway Project Phases 3 and 4.
  - A meeting regarding CCRT Bikeway Phase 3 had been scheduled for February, 2024 but the State has postponed it to the summer.
- Unitarian Church project.
  - It was noted that this project is also nearing completion and looks quite nice. A final inspection will be scheduled.
- Olde Colonial Court House building.
  - It was noted that reimbursements are coming through for work on the porch, ramp and lift, with the project anticipated to be completed by the end of April.
- The Barnstable Historical Society building is also anticipated to be completed in the next month or two.
- Progress is being made on the Centerville and Osterville Playground projects.
  - o A full update will be given by Mark Marinaccio at a future date.
- Discussion at the request of the Cotuit Federated Church Pastor Angela Menke Ballou is tentatively scheduled for March 18, 2024.
- It was noted that the Community Preservation Committee needs a new Recreation Committee representative appointed. There was a brief discussion regarding the process for appointment of a representative.

The revitalization of the John F. Kennedy Memorial in Hyannis, Massachusetts is a project of critical importance and strong justification.
