The meeting was called to order at 6:30 p.m. by Chairman Dennis R. Houle. Also attending were Vice-Chairman John Abodeely and Commissioners Peter Sampou, Scott Blazis, Tom Lee, and Louise Foster. Commissioner Larry Morin was away. Rob Gatewood, Conservation Administrator, assisted.

II REQUESTS FOR DETERMINATION

Massachusetts Highway Department. Proposed drainage improvements by addition of catch basins to eliminate puddling/icing on Route 6A. **DA-08068**

The applicant was represented by Tom McGuire.

Issues discussed:

• Invert elevation not shown on plan

Issues discussed:

• Close collaboration with staff to ensure a defined short-crop view shed, otherwise an undulating cut 4 to 7 feet high.

Douglas Fearon. Remove existing house section and construct addition; replace and expand existing terrace at 310 Pine St., W. Barnstable as shown on Assessors Map 176 Parcel 001-002. **DA-08067**

Cotuit Oyster. Amend plan by relocating proposed building, shortening pier array & modifying site design as per plans revised through 5/27/08, at 26 Little River Rd., Cotuit as shown on Assessors Map 053 Parcel 009. **SE3-4095**

The applicant was represented by Arlene Wilson and Attorney Mary Elise Kelly.

Issues discussed:

• A revised plan was proposed as part of a settlement agreement. (Cotuit Oyster, cont'd.)

- Use of biodegradable hydraulic fluid for power lift with diked pad beneath.
- No storage of hazardous material beneath the building.

A motion was made to amend the Order of Conditions.

Seconded and voted unanimously.

VI CONTINUANCES

A. **Robert Bothwell.** Modification of existing stairway, pier and float for the installation of two benches, a 6ft. canoe/kayak rack, a small hand-cranked boat lift, the enlargement of the existing float from 8' x 12' to 10' x 20', and the relocation of two existing 8" timber piles at 252 Clamshell Cove Rd., Cotuit as shown on Assessors Map 005 Parcel 004. **SE3-4740**

The applicant was represented by Arlene Wilson and Attorney Walter Sullivan.

Issues discussed:

- The requested "spec" sheet on the proposed boat was recently submitted
- The proposed boat, a 37-ft. Ocean, drafts slightly less than the Cabo allowed presently at the pier (also has less hp)
- Whether the enforcement order is specific to the Cabo
- Whether the 12-inch draft restriction in the Order of Conditions is all that currently binds the applicant
- The unpermitted status of several features of the existing pier (float size, outhauls, bench, lift)
- How the deep hole occurred, and whether it constitutes Mr. Bothwell's violation
- The importance of the shellfishery.

A motion was made to continue the hearing to August 19th.

Seconded and voted unanimously.
