A. Use of planks for a simple boardwalk/appropriate filing?

The Commission stated that a Notice of Intent application will be needed for any use of planks, boards, or walkways in a resource area. The reason is that the structure must be designed to be raised up, off the ground.

B. Long Pond Community Gardens – parking

The Commission supported the increase/expansion of the parking area near the road, if needed.

C. John Wilson – proposed mitigation plan – 151 Irving Ave.

Attorney Sarah Turano-Flores represented Mr. Wilson, and Attorney Michael Ford represented Senator Kennedy.

A motion was made to approve a new mitigation plan showing only grasses to be planted; no cedar trees or native shrubs will be planted.

Seconded and voted unanimously.

D. Other

The Chair informed the Commission of the difficulty in opening the Crocker Neck conservation area gate. An overtime reimbursement issue has arisen with the union. The matter is currently being grieved through the Town process. Until it is resolved, the summer schedule for opening and closing the gate will not be instituted.

A motion was made to adjourn.
