# MINUTES – CONSERVATION COMMISSION MEETING

The meeting was called to order at 8:30 a.m. by Chairman Dennis R. Houle. Also attending were Vice-Chairman Tom Lee, and Commissioners John Abodeely, and Larry Morin. Commissioner Louise Foster was away, and Peter Sampou and Scott Blazis were teaching. Rob Gatewood, Conservation Administrator, assisted, along with Darcy Karle, Conservation Agent, and Fred Stepanis, Conservation Assistant.

The meeting was held in the Hearing Room, Barnstable Town Hall, Hyannis, MA.

#### **III ENFORCEMENT ORDERS**

A. David J. Der Hagopian – 265 Ocean View Ave., Cotuit Alteration of a resource area, coastal bank, by removing 4 cedar trees, 6" to 8" diameter on a coastal bank.

Mr. Der Hagopian was represented by Attorney Kevin Kirrane.

A motion was made to issue a second enforcement order, stating the following:

"Remove cut slash on bank by July 9, 2009. Replanting mitigation plan shall be submitted to, and approved by, the Conservation Agent by July 15, 2009. The plan shall show replanting of cut trees, in-kind inches, or other suitable mitigation ideas, e.g., removal of invasive species to make up for the inches that cannot be planted due to steepness of bank. Previous replanting report for this property should be reviewed for ideas. Native trees shall be used and water supplied. Planting shall take place by September 15, 2009."

Seconded and voted unanimously.

B. Edward C. Lenk – 206 Wheeler Road, Marstons Mills
SE3-4711
Contractor – Phil Miller of Miller Starbuck Construction Inc.
Alteration of a boardering vegetated wetland and 50' buffer zone by 1" to 2" of silt from failed siltation controls
Failure to install a complete section of siltation controls near boat house.
Failure to use any siltation fencing behind haybales.

Construction of a retaining wall not shown on the plan of record. Failure to submit protocol to protect trees on or near work limit as stated in special conditions.

"Property owner shall have an engineer submit a protocol for protection of trees on or near the work limit line. A revised plan shall be submitted for the retaining wall. Siltation control status reports shall be submitted once a month to the Conservation Division by the engineer. "

A motion was made to amend the enforcement order to read:

"Remove or file a Notice of Intent for the seasonal dock structure by July 1, 2009; file a Request for Determination for other item stored on the property."

Seconded and voted unanimously.

Joan Delnegro – 99 Rosemary Lane, Centerville
Alteration the Commission's 50' undisturbed buffer zone, by the construction of a retaining wall, associated fill, above ground pool, associated deck, and ground level deck.

Ms. Delnegro represented herself.

A motion was made to amend the enforcement order as written to read:

"File a Notice of Intent or remove all unpermitted structures and replant disturbed areas in consultation with staff by July 25, 2009. "

Seconded and voted unanimously.

F. Daniel Salvatore and Roxanne Pappas – 110 Prince Ave., Marstons Mills **SE3-4502** Cutting trees within the River Protection area, failure to cease and desist mowing near river, failure to request a certificate of compliance for SE3-4502.

A motion was made to approve the enforcement order as written.
