### MINUTES - CONSERVATION COMMISSION MEETING

DATE: May 4, 2010 - 6:30 P.M.

#### LOCATION: TOWN HALL HEARING ROOM

The meeting was called to order at 6:30 p.m. by Chairman Dennis R. Houle. Also attending were Vice-Chairman Tom Lee, and Commissioners Peter Sampou, Scott Blazis, Larry Morin, and Louise Foster. Commissioner John Abodeely was away. Rob Gatewood, Conservation Administrator, assisted.

The meeting was held in the Hearing Room, Barnstable Town Hall, Hyannis, MA.

#### I CONTINUED PUBLIC HEARING ON PROPOSED REGULATIONS FOR SHORE OUTHAULS

The Chairman read the several changes that were incorporated into the draft regulations as a result of the initial public hearing. These changes pertained to the "grandfathering" section and the regulations section, where a revocation clause was added.

#### Public comment:

Attorney Stuart Rapp, on behalf of the Shellfish Committee, requested the Commission to strike the phrase "legal document recorded at the Registry of Deeds," on Page 6.

A suggestion was made to add the phrase "but not limited to," after "including" on Page 11.

Arlene Wilson, PWS, requested that outhauls approved in Orders of Condition or Determinations of Applicability also be listed on Page 6 as proof of Town approval.

Phyllis Cole asked that she be allowed to speak on her parcel on Bay Street. The Chairman denied the request, as the Commission will be hearing a future application on that parcel's outhauls. Ms. Cole stated that she has shellfished since 1963, specifically around the outhaul posts.

Staff requested that "Determination of Applicability" be listed after "Order of Conditions" on Page 6 in the new revocations section.

The Chair stated that the deadline date for receiving applications for existing outhauls will be changed to September 1, 2010.

The Chair added that the Legal Department would like to discuss the "grandfathering" section of the proposed regulations in the weeks ahead.

A motion was made to continue the hearing to June 1<sup>st</sup>.

Seconded and voted unanimously.

• A great deal of material being stored on shore.

**Arne & Sarah Ojala.** Construct 12' x 24' addition to existing garage; remove 2 pitch pines; relocate retaining wall and split-rail fence; install dry well at 211 Maple St., W. Barnstable as shown on Assessors Map 132 Parcel 005. **DA-10022**

• Drywell proposed for roof runoff.
