Commissioners Peter Sampou and Scott Blazis were teaching, and Commissioner Larry Morin was away. Rob Gatewood, Conservation Administrator, assisted.

E. Tobin SE3-4494 single-family dwelling vegetation management

The applicant was represented by Peter Sullivan, P.E.

Issues discussed:

- Photographs were presented and noted for the file as Exhibit A, 1-4.
- Prior consultation with staff will be required for vine management.

A motion was made to approve the revised plan.

## II ENFORCEMENT ORDERS

A. William Quirk Jr. – 104 Swallow Hill Road, Barnstable
Violation at 0 Indian Trail, Barnstable (Barnstable Land Trust Property)
Alteration of the Barnstable Conservation Commission 50' undisturbed buffer zone and 100' buffer zone by cutting vegetation. Cutting is within proximity of a pond to the east and a shrub swamp to the west.

Mr. Quirk was represented by Peter Sullivan, P.E. The Barnstable Land Trust was represented by Jaci Barton of the B.L.T., and Attorney Largay.

Issues discussed:

- Location of the cutting violation as shown on a US GIS plan was submitted by Ms. Karle and noted as Exhibit A.
- Photographs taken on 12/8/10 by the Agent were displayed and noted as 2A 2E.
- Ms. Barton stated that volunteers counted 120 stumps. She submitted the following for the record: Exhibit A1 A9.
- Photos taken on 12/8/10 by Red Bansfield of the Land Trust;
- Exhibit B, Sketch Diagram (GIS);
- Exhibit C, Sketch Diagram (aerial, undated);
- Exhibit D, Grid location of cut stumps;

- Exhibit E, Chart "Tree Cutting on Warren property."
- Mr. Sullivan requested additional time to retain legal counsel to look into cutting done by the prior owner.

A motion was made to approve the enforcement order as written. An extension to deadlines will be allowed, in consultation with staff.

Seconded and voted unanimously.

 B. John Mikutowicz Tr. – 59 Point Isabella Road, Cotuit Alteration of the Barnstable Conservation Commission's 50' undisturbed buffer zone and 100' buffer zone by clearing vegetation to create a garden and planting bed.

Mr. Mikutowicz appeared at the hearing.

Issues discussed:

- Exhibit A aerial photo dated April, 2001, showing prior natural vegetation, was displayed and noted;
- Exhibit B aerial photo dated April, 2008, showing natural vegetation cleared was displayed;
- Exhibit C aerial photo dated July, 2009, showing location of garden and planting bed, was displayed.

A motion was made to amend the enforcement order to read that a Notice of Intent must be filed to seek approval for the garden located within the 50-foot undisturbed buffer zone. Alternatively, planting mitigation within Conservation jurisdiction to be applied for, in consultation with staff.

Seconded and voted unanimously.
