MINUTES – CONSERVATION COMMISSION MEETING

DATE: July 22, 2014 at 6:30 p.m.

The meeting was called to order at 6:30 p.m. by Chairman Dennis R. Houle. Also attending were Vice-Chairman Tom Lee and Commissioners John Abodeely, Peter Sampou, Scott Blazis, Larry Morin, and Louise Foster. Rob Gatewood, Conservation Administrator, assisted.

The meeting was held in the Hearing Room, Barnstable Town Hall, 367 Main Street, Hyannis, MA.

I CONSERVATION COMMISSION REORGANIZATION

A motion was made to re-nominate the existing leadership of the Commission: Dennis R. Houle, Chairman, and Tom Lee, Vice Chairman.

Seconded and voted unanimously.

A motion was made to approve the minutes (A - B).

Seconded and voted unanimously.

III REQUESTS FOR DETERMINATION

James & Deborah Fowler III. Construct 2nd floor addition in existing footprint; replace existing posts with sonatubes to support existing deck and roof; pruning of 2 trees and landscape improvements; remove existing wood deck and walkway at 346 Holly Point Rd., Centerville as shown on Assessor's Map 232 Parcel 024. **DA-14042**

The applicants attended, and were represented by Peter Hansen.

A motion was made to issue a negative determination.

Sea Side Park Improvement Assoc. Seek approval for installed crushed stone area to house 10-bike rack make of recycled materials, and place 2 kayak racks of pressure-treated wood at 3 Beach St., W. Hyannisport as shown on Assessor's Map 245 Parcel 035. **DA-14044**

The applicant was represented by Mark Joyce, Charles Cormay and James Harrington (ex-president).

A motion was made to issue a negative determination.

Seconded and voted unanimously.

Sea Side Park Improvement Assoc. Seek to maintain 5 dinghy tie-up posts and add 2 additional posts (pressure-treated) connected by 20-ft. chain at 5 Beach St., W. Hyannisport as shown on Assessor's Map 245 Parcel 137. **DA-14045**

Anastasia Marty, Tr., 249 Long Beach Rd. Realty Trust. Re-plant beach grass seaward of concrete wall that has been removed at 249 Long Beach Rd., Centerville as shown on Assessor's Map 185 Parcel 029. **DA-14046**

A motion was made to issue a positive determination.

Seconded and voted unanimously.

A second motion was made for a show-cause hearing for the removal of stairs from a resource area without prior authorization. Seconded and voted unanimously.

IV NOTICES OF INTENT

Ronald & Sue Lareau. Permitting of a pre-existing dock and extension at 22 Pond St., Centerville as shown on Assessor's Map 230 Parcel 087. **SE3-5207**

The applicants attended the hearing.

The conditioning for the project will follow that of the adjacent Babbitt pier, approved at the last meeting.

Seconded and voted unanimously.

Harry Taylor. Redevelop existing residential property involving direct alteration of coastal bank and land subject to coastal storm flowage, and within buffer zone of other wetland resource areas at 56 Sand Point, Oyster Harbors, Osterville as shown on Assessor's Map 073 Parcel 017. **SE3-5208**

The applicant was represented by Atty. Michael Schulz and Jack Vaccaro.

The extent of mitigation required for this raze-and-rebuild project was discussed at length. Restoration of the 50-foot buffer to the bay-fronting coastal bank was desired by the Commission. To accomplish this, a reduction in new proposed hardscape within the 50 will be needed.

A motion was made to continue the hearing to August 5th.

Seconded and voted unanimously.

Andrew Slifka. Demolish existing dwelling; construct new single-family dwelling, detached pile supported accessory structure; pool with patio and cabana, utilities and associated appurtenances at 67 Caillouet Ln., Osterville as shown on Assessor's Map 141 Parcel 097. **SE3-5210**

The applicant was represented by John O'Dea, P.E. and Jimmy Bowes.

John Garabedian/CODCOMM, Inc. Expand existing parking lot; stormwater management improvements at 243 South St., Hyannis as shown on Assessor's Map 326 Parcel 005. **SE3-5209**

The applicant was represented by P. Griffin Beaudoin.

Reduction of project impact within the 50-foot buffer was requested by the Commission.

A motion was made to continue the hearing to August 19th.

Seconded and voted unanimously.

V CONTINUANCES

Three Bays Preservation, Inc. & Mass. Audubon Society, Inc. Proposed barrier beach management plan to include maintenance dredging and beach nourishment and other activities to enhance wildlife habitat and maintain integrity of barrier beach; proposing to remove the western-most 800 ft of Sampson's Island via dredging, and to use this sand to fortify the eroding front beach at Dead Neck. **SE3-5053**

The applicant requested a continuance, via letter, to September 30th.

A motion was made to continue the hearing to September 30th.

Seconded and voted unanimously, with one abstention.

No testimony was taken.

The ways-to-water are not owned by the Town.

A motion was made to advise the property owners of that fact and that they should consult with staff prior to undertaking any future repairs.

Seconded and voted unanimously.

The Commission discussed that a future discussion on this matter would be useful. It will take place on September 16th

A motion was made to adjourn.
