## IV REQUESTS FOR DETERMINATION

Elva L. & Lawrence R. O'Brien III, Trs. of Elva L. O'Brien Revocable Trust. Request to resume annual bank vegetation maintenance, including pruning rosa rugosa hedge, removal of invasive vines from trees, removal of dead branches and standard vista pruning at 205 Ocean View Ave., Cotuit as shown on Assessor's Map 033 Parcel 025. DA-14047

The applicant was represented by Chuck Rowland, E.I.T.

A motion was made to issue a negative determination, allowing standard vista pruning, annual maintenance of rosa rugosa, and cutting invasive vines in the cedars on the bank in consultation with the Conservation Agent.

Improvements would be located at 60 Oregon Way and at 0, 1524 and 1541 Main St, Cotuit as shown on Assessor's Map 016 Parcel 011 and Assessor's Map 017 Parcels 015-001, 014, and 007.
