I OLD & NEW BUSINESS

A. Public Hearing on proposed revisions to Ch. 706 Abutter Notification Regulation

The public hearing was opened.

A motion was made to amend Ch. 706, as proposed.

II REQUESTS FOR DETERMINATION

Town of Barnstable/DPW. This project is part of the US EPA project entitled; "Design and Construction of a Green Infrastructure Stormwater BMP Retrofit for One or More Municipal Properties on Cape Cod: A Demonstration and Education and Outreach Project." The proposed BMP would divert and treat stormwater from a 24-inch stormwater pipe that runs though the parcel and discharges in Hyannis Inner Harbor at the Gateway Marina. The green BMP will be a modified gravel wetland system and would treat the first flush of a storm event. After treatment, water would be returned to the pipe for discharge. **DA-15015**
