The meeting was called to order at 3:00 p.m. by Chairman F.P. (Tom) Lee. Also attending were Vice-Chairman Dennis R. Houle and Commissioners Peter Sampou (arrived at 3:20 p.m.), Scott Blazis, and Larry Morin. Commissioners John Abodeely and Louise Foster were away.

A motion was made to take items out of order, beginning with Old & New Business.

Seconded and voted unanimously.

I OLD & NEW BUSINESS

A. **Pratt SE3-1381** Construct addition & deck to single-family dwelling – Reconsider 9/22/15 denial of certificate of compliance at 630 South Main St., Centerville (BVD).

Carolyn Sheldrick, the current owner of the property, attended.

A motion was made to approve the certificate of compliance with conditions regarding the shed.

Seconded and voted: 3 votes = Aye; 1 vote = Nay. The motion carried.

II REVISED PLANS Project type: Revision:

A **TOB/DPW SE3-5322** water main replacement per NHESP comments 656 Mary Dunn Rd., Hyannis

The applicant was represented by Amy Ball of Horsley Witten.

Issues discussed:

- Mitigation planting plan not yet submitted; needs to address 3:1 and 4:1 ratios for patio addition under deck;
- Applicant offered to use a drip trench as mitigation instead of a planting plan.

A motion was made to table this matter until the May 10th meeting to allow time for consultant to submit a proper mitigation planting plan.

Seconded and voted unanimously.

The applicant was represented by Matt Creighton of BSC Group.

The request was to change the time-of-year restriction (TOY) set by the Town; applicant would like to work spring and early summer.

No one attended the meeting.

Ms. Karle explained that the property owner is requesting to swap out an approved wooden dock for an aluminum structure; dock section would increase from 3' to 4' in width.

A motion was made to approve the revised plan.

Seconded and voted unanimously.

III ENFORCEMENT ORDERS

A. **Triantafillou – 336 Huckins Neck Rd.** - Alteration of a resource area, 50' undisturbed buffer from a wooded swamp, by removing vegetation.

Ms. Nafsika Triantafillou was present.

B. **Childs – 75 John Maki Rd.** - Alteration of a resource area, 50' undisturbed buffer and 100' buffer from a wooded swamp and stream, by removing vegetation.
