BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES Town Hall Building, 367 Main Street, 2nd Floor Hearing Room, Hyannis, MA – 9:30 a.m. November 20, 2006

A regular meeting of the Barnstable Licensing Authority was held on Monday, November 20, 2006. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Richard L. Boy, Associate Commissioner, Thomas Geiler, Director of Regulatory Services, and Christine Ade, Recording Secretary. Sgt. Sean Sweeney, Liaison from the Barnstable Police Department, was absent.

Requests:

<u>One Day All Alcohol & One Day Entertainment License:</u> Application of Michael Brooks on behalf of Cape Cod Synagogue, 145 Winter Street, Hyannis, MA for permission for a One Day All Alcohol and One Day Entertainment License for an event to be held on December 9, 2006 from 7:00 pm to midnight.

Mr. Brooks appeared for his request. Mr. Burman clarified he is a member; there was determined to be no conflict from his sitting on this hearing. Mr. Brooks said there would be a DJ and some line dancing and a jazz trio. Mr. Hoxie asked about the servers; they are trained to serve alcohol.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of Michael Brooks on behalf of Cape Cod Synagogue, 145 Winter Street, Hyannis, MA for permission for **a One Day All Alcohol and One Day Entertainment License** for an event to be held on December 9, 2006 from 7:00 pm to midnight.

<u>One Day Beer & Wine and One Day Entertainment License</u>: Application of Anthony Todisco on behalf of **Cape Cod Tattoo**, 701 Main Street, Hyannis, MA for permission for **a One Day Beer & Wine and One Day Entertainment License** for a grand opening to be held on December 2, 2006 from 3:00 pm to 11 pm with a 4-5 piece band.

Mr. Todisco and Cheryl Valeri, his Manager, came in for this grand opening request. They officially opened 6 weeks ago. They have been asked by a band to promote them along with the shop. It will be advertised on FOX. They will actually play from 7 pm to 11 pm. That is also when the alcohol will be offered. They have arranged for a detail for 4 hours at \$160 and they have officers available that day. They have a licensed bartender from Sundancers to serve. Mr. Burman asked about reserving these licenses for non-profits; Mr. Geiler advised that the all alcohol ARE reserved for non-profits but beer and wine are for everyone. The band is acoustic and will be inside only. They also have a graphic design department. Mr. Burman asked who there neighbors are; they are a free standing building – neighbor is a hair salon and will be attending their opening. Mr. Burman is concerned with the neighbors behind them. Cheryl stated there is an empty lot behind them.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of Anthony Todisco on behalf of **Cape Cod Tattoo**, 701 Main Street, Hyannis, MA for permission for **a One Day Beer & Wine and One Day Entertainment License** for a grand opening to be held on December 2, 2006 from 3:00 pm to 11 pm with a 4-5 piece band.

Hearings:

Transfer of Annual All Alcohol Package Store License and Change of Location: Application of Iyanough Package Store, Inc., d/b/a Airport Liquors, 384 Barnstable Road, Hyannis, MA 02601, Jaycine Hedlund, Manager, for Transfer of its Annual All Alcohol Package Goods Store License and Change of Location to A.J. Luke's of Hyannis, Inc., d/b/a Luke's Super Liquors, 395 Barnstable Road, Hyannis, Arthur J. Luke, Manager, the hours of operation to be 9 am to 9 am to 11 pm.

Paul Covell appeared with Arthur J. Luke and Christina Luke. They seek tohave the license transferred to them and relocate across the street. Mr. Luke has extensive experience in the business – grew up in the business. A.J. on his own bought a package store in Pembroke and it has been sold; he has another in Brewster. The opportunity came along for the old Aubuchon building which is a superior location. They are requesting 11 pm closing unless it is slow time – then they would close at 10. They plan to operate the new facility in about 1-1/2 months. Assume they would be open March 1st. Mr. Sullivan made the statement that the area should not be impacted at all. Mr. Boy asked if they are affiliated with the Lukes in Yarmouth; the Yarmouth franchise is operated and owned by his father, with the same first name. Mr. Luke owns two package stores already – Brewster and Dennis. The Lukes' record is extraordinary for many years.

James Norton came forward as owner of Parker's Discount Liquor store. He said he had some administrative questions for the Board. It is his understanding that the Board can transfer or grant a license based upon the need of the community. He stated that Airport Liquors for the past 6 months has not been serving the needs of the community. If you were to go there today there is probably only \$1,000.00 in inventory. In the past 60 days he has personally observed that the store has been closed 41 days out of 60 days. How is it then serving a public need? Thirdly, the store has been posted with the ABCC for over a year – there are four vendors to which Airport Liquors is indebted.

They can only get deliveries now C.O.D. He stated the negotiation with Lukes has gone on since July of last year. He stated that the contract with Airport Liquor to Lukes is not valid. The Schedule B on the P&S is missing in our filing. Mr. Norton requested a copy of the contract and was told the Board did not actually review these contracts. He suspects there will be a bankruptcy filing subsequent to the transfer to Lukes. He stated the contract for sale is also unique – sale price stated as \$290,000. The unique thing is that there is \$150,000 not going to the corporation. It is going personally to the shareholders of the corporation which he feels is a diversion to get out of payment of debts. The Lease has not yet been signed; the option to Lease states \$25,000 in improvements will be made. Mr. Norton stated that is impossible because the building is in such deplorable condition. He states the application is deficient. He states the Board should decline the application until full disclosure is made.

Mr. Burman recused himself from this hearing as his real estate company was involved in the sale. Mr. Boy will be sitting.

Mr. Covell stated that he presented today a fit applicant to hold the License under rules of Chapter 138. With respect to the sale issues; he doesn't feel he should speak on behalf of the current owners - Airport Liquors. Everything has been reviewed by Lukes' attorney and is all fully legal and appropriate. Mr. Luke stated the debt to the business is \$11,000. He had bought a store in Dennis which was over \$100,000 in the hole. That us not a problem. There is now an executed Lease - it was not signed at application time. Mr. Hoxie asked if the applicant reviewed the sales activity over a few years. Mr. Luke stated they did review it and noticed the store was going downhill. They feel the divider in the road did not help them but are confident that their operation will succeed as his other stores have succeeded. Mr. Covell feels the location will serve the public need. However, this is not a new license and is not one of the tests which need to be met for a transfer of license. The new building will allow for ample inventory. They have met with the building commissioner and satisfied their requirements to move forward. Mr. Sullivan does understand Mr. Norton's comments to some degree but for the record states this is not a new license. It is a transfer of a license already existing. The fact that it is not successful is the parking lot location as well as internal problems. The way the road was laid out and changed has caused them a lot of problems. This will not affect the new location. The need continues to be there. Mr. Boy stated the Lease is subject to the granting of this license which totally makes sense. It meets al the requirements we need. Mr. Sullivan also stated that this is an improvement over the current licensee because of their good record in the liquor business. Mr. Luke asked if the Board had a problem with them not being open until February or March. Mr. Geiler stated they need to talk with us after approval by the ABCC to address the opening logistics.

Luke's of Hyannis, Inc., d/b/a **Luke's Super Liquors**, 395

Barnstable Road, Hyannis, Arthur J. Luke, Manager, the hours of operation to be 9 am to 8 am to 11 pm.

Juliano Coutinho appeared for the application. He will buy the cars from auction for sale. He has experience in Brazil and here selling used cars. He will do no repairs or washing of cars on site. Mr. Burman is concerned that nothing will be outside. Mr. Coutinho stated there are two parking spots and a handicapped spot for customers as well as three parking spots on the side. Mr. Hoxie asked what is there now. Mr. Coutinho stated it is a landscape bay there now.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the application of Juliano Sousa Coutinho, d/b/a ES Auto Sales, Juliano Coutinho, Manager, for **a New Class II Automobile Dealer's License**, 30 Rosary Lane, Hyannis, with 3 display vehicles inside; none outside, and hours of operation 9 am to 4 pm six days per week with stipulation that there be appropriate parking for employees and customers on the outside.

There will be pastries, etc. no donuts. They will try to open tomorrow if all inspections are in. The hours will be based on volume. A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the application of Marylou's News., Inc., d/b/a **Marylou's Coffee**, 1481 Iyannough Road, West Barnstable, MA, Caitlin M. Imbrogna, Manager, for a **New Common Victualer License**, the hours of operation to be 5 am to 7 pm.

Transfer of All Alcohol Common Victualler License, Daily Live and Sunday Entertainment Licenses: Application of Regatta of Cotuit, Inc., d/b/a Regatta of Cotuit, 4631 Falmouth Road, Cotuit, Brantz M. Theodore Schilling appeared with Mr. Fizell, President and Treasurer of C&C Foods, Inc. and proposed Manager. He is buying the real estate and the restaurant. He has 20 years in the industry. The business will stay the same – even the staff. Mr. Sullivan did not notice the capacity of the restaurant. Mr. Schilling stated it as 116 but they will be doing only 93.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the application of Regatta of Cotuit, Inc., d/b/a Regatta of Cotuit, 4631 Falmouth Road, Cotuit, Brantz M. Bryan, Jr., Manager for **Transfer of it's Annual All Alcohol Common Victualler License, Daily Live Entertainment and Sunday Entertainment Licenses** to C&C Foods, Inc., d/b/a **Regatta of Cotuit**, Weldon Fizell, Manager.

<u>Show Cause Hearing</u>: Show Cause Hearing for Derrick, LLC, d/b/a Grille 16 at the Asa Bearse, 415 Main Street, Hyannis, Mark Ventre, Manager, as a result of information received for alleged violation of the terms of its Annual All Alcohol Common Victualer License in that it did fail to obtain the necessary permission of the local Licensing Authority and the Massachusetts Alcohol Beverages Control Commission to change the membership or ownership of the establishment and did violate the terms of the Town of Barnstable Code 501-6P it that it did use an assumed or trade name for which it had not obtained permission from the local Licensing Authority or ABCC.

Mr. Hoxie read the hearing notice. Mr. Hoxie asked if Sgt. Sweeney, who is involved in an investigation at the last minute, had a report to make. Mr. Geiler stated that it is his understanding the issue has been resolved. Mr. Hoxie stated that the name changed without permission and the manager of record was not present. Richard Angelini came to the podium to advise the Board of the chain of events. Mr. Sanderson and Mr. Ventre also appeared. On May 5, 2006, Mr. Angelini signed an agreement with Mr. Ventre to change the manager and on May 17th the Commonwealth approved the change of ownership, which unfortunately was not brought before the Town and the ABCC. It was simply an error of omission. On October 22nd Mr. Angelini spoke to Mr. Geiler who advised the place was open – it was news to Mr. Angelini who stated he would try to reach the parties involved. He advised Mr. Jasset, who represented himself

to be the Manager, to call Mr. Geiler immediately to get things in order. He spoke to Mr. Geiler again advising he no longer had an ownership and the owners would be correcting paperwork for the Licensing Authorities. Mr. Angelini is disturbed that at the last meeting it was stated that the owners were thumbing their noses at the Authority. He stated he has always been very cooperative with this Authority. Mr. Hoxie asked who is responsible; he stated Mr. Ventre is manager of record and will speak for himself. He stated they were in the process of changing the ownership of Grille 16 to an individual. There was a timeframe for the individual to get financing in place. In the interim they allowed the person to come in and change things around; did not give him permission to change the name, etc. When they found out there were problems, they closed the restaurant down. They are now negotiating elsewhere. Mr. Hoxie stated that as long as they are closed now it is o.k. but it caused the Authority concern when they read in the paper that the name had changed and there was a grand opening with a manager not the manager of record, and that was confirmed by a police officer. He said that we had reason for great concern. Mr. Burman asked if an application has been submitted to remove Mr. Angelini as owner - this has not been done locally; they thought it had been done by the State and were not aware of the local and ABCC requiements. Mr. Burman stated Mr. Angelini has always been very respectful and cooperative. Mr. Ventre stated they are trying to work things out and had no idea what had been happening with the newspaper, etc. Mr. Hoxie stated he would be happy to receive applications.

Bill Roland, operator of a couple restaurant groups off Cape is negotiating to go through the hurdles to take over this operation as quickly as possible. He is leaning towards keeping the name of Grille 16. Mr. Burman asked if the unnamed individual will be involved? Mr. Roland stated he is not part of their operation at all. He has 4 other locations and will make sure he provides this Board with whatever it needs. Mr. Sullivan asked what they are trying to do. Their management company will open the business as it is currently formed and work with them to get it running properly. They will come before the Board later if the manager of record will change. The change of ownership will not take place at this time. Mr. Geiler stated the difficulty here is that a management agreement such as that is not legal in Massachusetts. They can be "employees" of the existing corporation and run the facility. Mr. Geiler stated that we would want to see a contract. Mr. Hoxie stated they should renew as is – the renewal must be in by 11/30/06. Mr. Roland stated that will be done immediately and they will address the changes in the future.

Mr. Burman made no findings on the Show Cause Hearing. Mr. Hoxie stated there are violations – they changed the name without permission, are not open without permission. Mr. Burman stated that at this point the owners are proceeding as best they can to do the right things. Mr. Hoxie asked Mr. Geiler for recommendations. Mr. Geiler recommended from the Town's standpoint that what was happening was egregious to many individuals and was illegal. The discussions he had with Mr. Angelini provided more information and that Mr. Sanderson did come down to discuss with the people running it that they had to close until such time as corrections could be made. He believes everything we needed to have happen has now happened because of the

discussions with the owners and the new management company. Mr. Hoxie thinks a motion would be in order that no action be taken.

Mr. Burman made a motion which was seconded by Mr. Sullivan and a unanimous vote taken that no action be taken on this show cause hearing.

Discussion on Kendricks: status of ABCC remand. Status of Town scheduled hearings, status of renewal and status of restaurant.

Mr. Burman asked about the serving of a minor hearing – Mr. Geiler stated we have nothing on that yet. He also stated he is not sure what we want to do with our hearing appeal and the closing. It is our understanding all the repairs are not complete – we do not know what their plans are to reopen. We are probably better off to wait until we have a dialogue with them before going forward. Mr. Burman asked if we want to go on record by letter to leave our options open for appeal to Superior Court.

Mr. Geiler stated that their letter to us was a remand; that our decision was not a good one and they are reversing it. Mr. Burman still would like a letter to the ABCC clarifying their position. Mr. Geiler stated our focus has been to insure that when or if they open they open in compliance with all requirements – ours as well as health and building issues. The establishment has been struggling to find a niche and if they will be in next

meeting it should be an opportunity to have a dialogue. Mr. Hoxie would like the dialogue prior to renewing the license.

Mr. Hoxie disagrees with the ABCC letter – thinks we should talk to counsel as we did NOT agree that shots came from the parking lot. Mr. Sullivan asked if the ABCC remanded the decision. Mr. Geiler believes it was a remand based on Chapter 138. The language in the letter could be easily read as a directive. Mr. Sullivan stated we made a decision; out attorney made a recommendation to the ABCC and they remanded the file. Should we then be looking at the testimony as to these cases in the future? Mr. Hoxie would like Mr. Geiler to talk to counsel, which he agreed to do.

Mr. Geiler stated that on the 4th we will be handling the rest of the alcohol renewals – they have to be sent to the ABCC. Mr. Geiler stated we will continue to contact licensees to get their renewals in. We do not want them to have to apply for new licenses. It has been policy to contact the stragglers before the end of the month to get in and file as the alcohol renewals must be filed in November. Additional renewals will come in on the 18th for non-alcohol and some will not come in until early spring.

Mr. Hoxie adjourned the meeting until December 4th.
