Scott Saulnier appeared for their application. Scott represented that the new signs are being requested for the entertainment area on the rear. The sign has been approved by Historic and they have the sign. Mr. Burman asked if it was two licenses; Mr. Saulnier stated it is one license. Mr. Geiler stated he has no problem with it.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of SPSS Enterprises, LLC, **d/b/a Asa Grill**, Scott Saulnier, Manager, 415 Main Street, Hyannis holding an Annual All Alcohol Common Victualler License for **An Additional d/b/a, Reputation.**

Other Business:

Mr. Geiler reported that on the Kendrick’s appeal of the Licensing Authority’s decision regarding non-renewal of heir license – the day prior to the hearing the attorney for Kendrick’s requested it be continued as it would “most likely be withdrawn.” However, we have received nothing yet. It sounds like there may be a forthcoming notice from the ABCC that the Kendrick’s appeal has been withdrawn and that we would go back to the decision of no renewal of their licenses.

There being no further business, it was confirmed that the next meeting is on August 27, 2007.
