BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES

Town Hall Building, 367 Main Street, 2nd Floor Hearing Room, Hyannis, MA – 9:30 a.m.
October 1, 2007

A regular meeting of the Barnstable Licensing Authority was held on Monday, October 1, 2007. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Dick Boy, Associate Commissioner; Thomas Geiler, Director of Regulatory Services and Licensing Agent, Lt. JoEllen Jason and Patrolman Steven Maher, Liaison from the Barnstable Police Department, and Christine Ade, Recording Secretary.

Requests:

One Day Entertainment License: Application of Kerry Aylmer, 92 Barnacle Road, Yarmouthport, MA, for a **One Day Entertainment License** for a Halloween Party to be held at the VFW Hall, Hyannough Road, Hyannis, on October 27, 2007 from 8 pm to 11 pm at which Freddie & The Maybellines will play (7 piece band).

Mr. Aylmer appeared for this request. He stated the license is to charge at the door for the entertainment.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of Kerry Aylmer, 92 Barnacle Road, Yarmouthport, MA, for a **One Day Entertainment License** for a Halloween Party to be held at the VFW Hall, Hyannough Road, Hyannis, on October 27, 2007 from 8 pm to 11 pm at which Freddie & The Maybellines will play (7 piece band) and an admission fee will be charged.

One Day Entertainment License: Application of Carol Schwanhausse, for a **One Day Entertainment License** for music to be performed on an electric keyboard for a pre-wedding party to be held at Wimpy's, 752 West Main Street, Osterville, MA on Friday, October 5, 2007 from 9 pm to 11 pm.

Danielle Siscoe appeared on behalf of Carol. This is for an un-amplified keyboard player. There is no charge but it will be at the restaurant, which does not have an entertainment license.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of Carol Schwanhauss, for a **One Day Entertainment License** for music to be performed on an electric keyboard for a pre-wedding party to be held at Wimpy's, 752 West Main Street, Osterville, MA on Friday, October 5, 2007 from 9 pm to 11 pm.

One Day Wine & Malt Licenses (4): Application of James Wolf on behalf of **Cotuit Center for the Arts, 4404 Route 28, Cotuit** for **4 One Day Wine and Malt Licenses** for a 2 art openings October 13 and November 24, 2007 (5 pm to 8 pm); for a concert/fundraiser on October 19, 2007 (8 pm to 11 pm) and a Masquerade Ball on October 27, 2007 (8 pm to 11 pm).

Mr. Wolf, Director of Cotuit Center for the Arts, appeared for these requests. They are the same type of events carried on successfully for some time now. He indicated that the October 19th event has now been switched to the 20th instead. He expects 100 people at the fundraisers. The Art openings usually have about 50 people in attendance.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of James Wolf on behalf of **Cotuit Center for the Arts, 4404 Route 28, Cotuit** for **4 One Day Wine and Malt Licenses** for a 2 art openings October 13 and November 24, 2007 (5 pm to 8 pm); for a concert/fundraiser on October 20, 2007 (8 pm to 11 pm) and a Masquerade Ball on October 27, 2007 (8 pm to 11 pm).

One Day & Sunday Entertainment Licenses: Application of Anne Hayes, on behalf of **Rotary Club of Hyannis, P.O. Box 39, Hyannis, MA**, for two One Day and a Sunday entertainment license for its annual home show to include a raffle, face painting, etc. to be held at the Barnstable High School Gymnasium & Field House from 10 am to 6 pm on Saturday, March 29, 2008 and from 10 am to 5 pm on Sunday, March 30, 2008.

Joseph Gatto appeared for this application, for the annual Rotary Club Home Show to take place at the High School. He apologized at the request of Anne Hayes for missing the last meeting and that she could not attend today. This is their 50th show – he stated Mr. Burman attended the very first show – was a young boy attending with his parents. Then Mr. Hoxie stated he was the President of Kiwanis at the time so could not be that young.

A motion was duly made by Gene Burman and seconded by Paul Sullivan and a unanimous vote taken to approve the request of Anne Hayes, on behalf of **Rotary Club of Hyannis, P.O. Box 39, Hyannis, MA**, for two One Day and a Sunday

entertainment license for its annual home show to include a raffle, face painting, etc. to be held at the Barnstable High School Gymnasium & Field House from 10 am to 6 pm on Saturday, March 29, 2008 and from 10 am to 5 pm on Sunday, March 30, 2008.

Other Business:

At Mr. Burman's request, Mr. Geiler told the Board that we received a complaint from neighbors of Up the Creek Again regarding noise and interactions. We have asked the Police Department to look at their log and asked the restaurant owner to provide a narrative response to the complaint. We have also sent a letter to the complainant as to what we are doing. We will look at the responses and proceed from there to make a determination.

Mr. Sullivan spoke on behalf of Robert Smith, stating that the Town will miss him terribly, and hopes we can find someone who will stand up to his fine standards. Everyone concurred.

Mr. Hoxie stated that the next hearing is October 29th, which was confirmed by Christine Ade.
