### BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES

Town Hall Building, 367 Main Street, 2<sup>nd</sup> Floor Hearing Room, Hyannis, MA – 9:30 a.m.

December 5, 2011

A regular meeting of the Barnstable Licensing Authority was held on Monday, December 5, 2011. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Thomas Geiler, Director of Regulatory Services and Licensing Agent, Richard V. Scali, Consumer Affairs Supervisor, Sgt. John Murphy and Patrolman Steve Maher, Liaison Officers from the Barnstable Police Department, and Christine Ade, Recording Secretary.

#### Hearings:

**One Day Entertainment Licenses:** Application of Carol Saunders on behalf of Hyannis Public Library, 401 Main Street, Hyannis, MA for One Day Entertainment Licenses for an Antiques show and sale to be held at BHS Field House, 744 West Main Street, Hyannis, on February 18, 2012 from 10 am to 5 pm and February 19, 2012 from 11 am to 4 pm.

Ms. Saunders appeared for this application. This sale has been held for many years, charging admission of \$6/person; \$5 with advance coupon. The event planner sets up the vendors. Mr. Burman made a motion to waive the fee, which was seconded by Paul Sullivan and approved by Mr. Hoxie.

A second motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Carol Saunders on behalf of Hyannis Public Library, 401 Main Street, Hyannis, MA for One Day Entertainment Licenses for an Antiques show and sale to be held at BHS Field House, 744 West Main Street, Hyannis, on February 18, 2012 from 10 am to 5 pm and February 19, 2012 from 11 am to 4 pm.

**Change Manager:** Application of Hess Mart of Mass., LLC, d/b/a Hess Express 21243, 50 Ocean Street, Hyannis, for a Change of Manager on its annual Wine & Malt Retail Package Store License from Donald Vieira to Heather Curtin.

Ms. Curtin appeared for this application as the proposed new manager. She does not have experience but has been a manager for Hess for a year. Ms. Sullivan confirmed that she will be taking the TIPS class before taking over as manager.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Hess Mart of Mass., LLC, d/b/a Hess Express 21243, 50 Ocean Street, Hyannis, for a Change of Manager on its annual Wine & Malt Retail Package Store License from Donald Vieira to Heather Curtin.

**New Annual Junk Dealer License:** Application of LeJean Louis, d/b/a Louis's Thrift Shop, 217 Main Street, Hyannis, MA, LeJean Louis, Manager, for a new Junk Dealer License, hours of operation to be 9 am to 5 pm, 6 days per week. Closed on Sundays.

Mr. Louis appeared for this application. He is taking over from Ms. Desil, who operated there before. Will also be selling some art from Haiti.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of LeJean Louis, d/b/a Louis's Thrift Shop, 217 Main Street, Hyannis, MA, LeJean Louis, Manager, for a new Junk Dealer License, hours of operation to be 9 am to 5 pm, 6 days per week. Closed on Sundays.

**Amend Daily Non-Live Entertainment License:** Application of Osterville Veteran's Assn., 753 Main Street, Osterville, Cornelius Andres, Manager, to amend its Daily Non-Live Entertainment License to add karaoke.

Neil Andres appeared for this application. They want to add karaoke to their license for the younger folks. Mr. Burman asked about karaoke being live or non-live; Mr. Geiler stated what is different is the audience participation. It is a relatively inexpensive option for licensees to help their business. Issues are different from dancing activities, etc. It is now being considered a separate category of license. In 2012 there will be a fee for this permit, but there is not now – it is just added to the license. Mr. Geiler stated it will help the police to know who has what to have it separated out. Officer Maher stated there are people who have come in for non-live music, background music which has morphed into karaoke – this area needs clarification. Mr. Burman stated it should be included in the live entertainment license. Mr. Geiler stated the main reason we did not do that is that with live the entertainer name must be recorded. With karaoke this would not be so, and would not be necessary. This will keep it simple. Mr. Burman stated this is just another layer of fees to charge those already struggling. Mr. Geiler stated we must have full cost recovery for those types of entertainment which should be 100% paid by the business entity. He said the fees are just one way the communities are able to stay afloat and provide the response the community expects.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Osterville Veteran's Assn., 753 Main Street, Osterville, Cornelius Andres, Manager, to amend its Daily Non-Live Entertainment License to add karaoke.

**Show Cause Hearing:** Show Cause Hearing for WJS Sports, LLC, d/b/a Play It Again Sports, 25 Lyannough Road, Hyannis, MA, for failure to file paperwork as requested by the Licensing Authority to change its location. The change of location has been filed so they have complied. Mr. Scali said we did keep it on the agenda as they had not complied and will be on the next meeting agenda. Mr. Geiler said he does feel they know what their responsibilities are. Mr. Scali also stated that we did include minutes of the prior decision against them that if they did not comply the suspension should be imposed.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to continue this hearing to December 19, 2011.

**Show Cause Hearing:** Show Cause hearing for Nadan Enterprises, Inc., d/b/a Barnstable News Store, 3220 Main Street, Barnstable, Robert Medeiros, Manager as the Licensing Authority determined at the end of May, 2011 that the license was not being operated by the corporation listed on the license, the license was seized May 27, 2011 and no-one has come forward to prove that the license was in fact being run by Nadan Enterprises, Inc., or that there is someone with a legal right to operate with the current license.

Robert Sherman appeared as prior president of Nadan Corp. He stated it was dissolved in the mid 1990's. He has not been running the store since even before then. Mr. Geiler stated also there are outstanding taxes due the state and other issues from the licensee after Mr. Sherman. In the spring we determined that the license was not being operated by Nadan, Inc., and advised those running it after seizing the license that they must prove they have a legal right to operate under that license, which they did not do. Mr. Geiler stated that this was a last attempt to find out if there is a legal entity to exercise the license. No-one came forward claiming to have that right.

Mr. Sherman stated he was contacted by Paul Covell, a Realtor, who wanted him to sign the license over to Mr. Ferraro, owner of the property. Mr. Sherman then called Mr. Geiler last December, who indicated that Mr. Medeiros had filed an application with us as Manager under Nadan. He stated he has never met Mr. Medeiros. Mr. Sherman does not intend to make the corporation whole again. Mr. Geiler stated there is an organization that wants to bring the store back to the way it was years and years ago. The residents of the village want to do that too. The Licensing Authority needs to revoke the present license so it can be open for reissue. Mr. Sherman stated he has no intention to hold anyone up for the future. Mr. Hoxie stated it looks like there was some fraud here. Mr. Geiler stated those people are long gone now. We need to get this "whole" again and get it back out there for

reissue. Mr. Hoxie sees nothing wrong with revoking the license we have already seized and then looking into going after those who falsified paperwork for years. Mr. Sherman said that he bought the business from Barnstable Realty Trust and was renting the building. He filed for bankruptcy in 1986, represented by Richard Cohen, and someone, he believes maybe Jimmy Smith, took over the lease and hired Mr. Medeiros as manager. He cannot prove that though. He last operated in the spring of 1987. He gave the keys to the attorney, who must have given them to Barnstable Realty Trust. It was not amicable. He stated he was not involved in discussions as to who would then be operating the store. Mr. Geiler stated we were not aware of Mr. Sherman's address until he got it from Mr. Covell earlier this year. He then made a call to Mr. Sherman, who lives in another part of the state. Mr. Geiler advised that when notice went out on this hearing we notified all who might be involved or have some standing to make a claim to the license. Mr. Hoxie asked if Mr. Sherman signed, or was applying year after year. Mr. Geiler stated it was NOT Mr. Sherman. Mr. Sullivan asked if he has been involved in another retail alcohol store since then; Mr. Sherman stated he has not. Mr. Geiler stated that by revoking the license it will allow the process to go forward. There is an appeal period after which the license could then be applied for. Mr. Geiler stated the police department could look into this. Mr. Geiler stated the motion should include that all of the interested parties were notified and the only one who responded by coming forward today as a legal prior owner is Mr. Sherman.

Mr. Hoxie and Mr. Geiler thanked Mr. Sherman for his appearance today. Mr. Sherman stated he was appalled at what has taken place. He stated he is available if need be for future action.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote for findings that all parties potentially involved in the operation of this license had been notified, and there has only been one response by a prior owner of the business, who is exonerated from this.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote for findings that the establishment was guilty of operating without a legal right to the license, and that Mr. Sherman is not guilty of anything with regard to this license.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to revoke the license held by Nadan Enterprises, Inc., d/b/a Barnstable News Store, 3220 Main Street, Barnstable, Robert Medeiros, Manager for an annual All Alcohol Package Store.
