### **Public Hearings:**

1. <u>Town of Barnstable Rules and Regulations</u>: The Barnstable Licensing Authority will hold a public hearing in accordance with Chapter 138 and 140 of the General Laws, and Barnstable Town Code, to hear the merits of adopting proposed amendments to Part V of the Town Code: Licensing Rules and Regulations.

Continued from August 22 hearing. Ms. Hartsgrove detailed all the changes and amendments being proposed. Ms. Hartsgrove and Tina Carey met for 2 hours. Revisions have been made to the Rules and Regulations. The public hearing has not been closed. Mr. Scali commented on all the work Ms. Hartsgrove has done on her spreadsheet. Section 502-1F, regarding TIPS certification; Managers and bartenders require TIPS and need to be re-certified every 3 years. Part—time employees only need internal training. Additionally, Package Store language has been clarified. Mr. Burman stated that employees being paid do not follow our purview. This is state law so it is required in all Rules and Regulations.

**Public Comment: Tina Carey**: 501-1C – This should be 9 months and 15 days not 2 days; clarifies the seasonal description. 501-7- Is this an insurance liability issue? Lt. Murphy stated this is a public safety issue; the issue of "should" vs. "will" call the police. Ms. Carey stated this is common sense issue, Lt. Murphy disagreed. She thanked Ms. Hartsgrove for all of her hard work.

**Attorney David Lawler**: There is no discretion provided for the business owner in dealing with "unruly and intoxicated". As this is written, this is very stringent and may be a recipe to cause problems.

**Attorney Steven Pizzuti**: Thanked Elizabeth Hartsgrove for paying attention to the Community. The procedure of having all boards/departments approves or signoff on an application prior to the Licensing Authority is too stringent. 509-4-B The requirement to pave/line if an amending a license should be for new licenses only. There is a possibility of a compromise for 50%.

Further discussion about the "call the police" issue was discussed. Attorney Pizzuti would like to see language added about the" reasonable discretion of the

manager if that person poses a risk to himself or others". Ms. Hartsgrove and Mr. Scali both reiterated that all licensees must comply with other boards prior to appearing before the Authority. Attorneys Pizzuti and Lawler both stated that this should be able to be done on a "contingent" basis.

The Board continued the hearing to October 17<sup>th</sup>.

2. Application to Amend Annual Live Entertainment license and to Include
Live Music on Upstairs Deck: Application of Lobster Girl Lobster Boy, Inc.,
d/b/a Raw Bar on Ocean Street, Elizabeth Westwater, Manager, 230 Ocean
Street, Hyannis. Amend request is to include live music on the upstairs deck.
Request is for 1 performer with 1piece. Hours of live music are Thursday-Sunday
5:00 PM to 8:00 PM.

Attorney Gildea represented the licensee; they have been in business for 9 years. Original application had entertainment downstairs and inside. They would like 1 performer outside. There is a surrounding residential area and the applicant is aware; and would be willing to engage a sound engineer to help with sound concerns. An acoustical guitar with one speaker and a singer with a microphone is what are being requested. Mr. Semprini proposed another seating of the entertainer to help mitigate sound. Mr. Semprini offered a motion to approve with no amplification, sides enclosed, direct music towards the boats. Motion was withdrawn.

**Public Comment**: Felicia Penn resides at 15 Daisy Bluff reviewed numerous details of complaints over the years and calls to the Police Department. She is opposed.

Patricia Marshall, 45 Channel Point Road is adamantly opposed.

Martin Reilly represents the owners of the building; Hi-Line cruises. He stated that operating from 5:00-8:00 pm is not that onerous. Also, that the applicant is willing to work with the neighbors.

Mr. Hoxie asked why there were individuals playing this year and last year outside on the deck in violation of their license and the Police Department responded. Lt. Murphy suggested moving this application to a later date to gather all police reports.
