SUBJECT: Rationale for the Deacidification and Binding ancient records

BACKGROUND: The Community Preservation Committee (CPC) met on May 16, 2006 and has recommended that the town support the modified funding request of \$5,000.00 from the Town Clerk to Deacidify and Bind Ancient records.

RATIONALE: The project goal is to deacidify approximately 100 books that include the history, vital records and other important documents of the Town of Barnstable. Preserving these books will help preserve the character and save these resources that are currently threatened by acidity. The said volumes would also be repaired and rebound if necessary. This project is vital to the Town's character. It is the Town's job to preserve that history for all times, for the use of historians and genealogists. If they are not preserved, the history will be jeopardized. The Town Clerk will return to ask for an amount not to exceed \$15,000.00 - \$20,000.00 toward this goal so that the project can be completed over a 4 or 5 year time frame. This project is part one of a two project series.

SUBJECT: General Ordinances Amendments - Comprehensive Occupancy and

BACKGROUND: In the original ordinances adopted by the Town Council on June 1, 2006 there were two minor errors that require correction. First, in section 59-2 of the General Ordinances, the Comprehensive Occupancy Ordinance, there was a lettering error in the definition of bedroom. An amendment has been submitted to re-configure the lettering of the clauses. In addition, the fee for the Rental Registration was originally placed in Section 76-4 of the Code with fees that are charged based on the Massachusetts General Laws. An amendment has been submitted to place this fee, more appropriately, in Section 76-6.

FISCAL IMPACT: None

TOWN MANAGER RECOMMENDATIONS: The Town manager recommends that the proposed amendments be adopted.

SUBJECT: Acceptance and Transfer Order for Barnstable County Land Management Program Grant

BACKGROUND: Barnstable County Land Management grant funding has been secured to construct a 500' handicap accessible loop trail at Santuit River Conservation Area in Cotuit.

ANALYSIS: Barnstable County Land Management grant funding provides the town with a cost-effective means of improving access to parcels managed by the Conservation Commission. The BCLM grant is intended to provide incentive funds for a broader public and private sector investment in land management. A town match is encouraged and considered during the grant review process.

FISCAL IMPACT: The local match for the grant is \$1,338.00, and will be provided through the Conservation Division's Land Management line item and with in-kind services.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends favorable action.

BOARD AND COMMISSION ACTION: A Land management plan, approved by the Conservation Commission for the Santuit River Conservation Area, includes public access improvements as a future goal.

2007-035 AMENDMENT TO THE GENERAL ORDINANCES -- BASIC AWARENESS ORDINANCE INTRO.: 10/19/06

AMENDMENT TO THE GENERAL ORDINANCES

ORDERED: That the General Ordinances of the Code of the Town of Barnstable be amended as further set forth herein.

SECTION 1 The Code of the Town of Barnstable, General Ordinances, is hereby amended by inserting the following in chapter 147, Peace and Good Order, after Article III, section 147-7.

"ARTICLE IV

CHILD SAFETY INFORMATION AND AWARENESS ORDINANCE

§ 147-8 Title

This ordinance shall be known as the "Barnstable Active Safety Information for Child Awareness Ordinance" and may be referred to by the acronym "BASIC."

§ 147-9-8 Purpose

The purpose of this ordinance is to advance the public safety and welfare of the residents of the Town of Barnstable by making certain environmental information and controls available for the benefit of children and those who care for children.

§ 147-10-9 Definitions

"CHILD," a person under the age of 16.

"FACILITY," place(s) for the conduct of the activities of a public or private enterprise.

"RESIDENCE," the place of abode of a person.

'SERVICES," an activity involving the exchange of public or private consideration other than goods.

§ 147-11 Information

(A) The Town will make available by publication on its web site and in one of its offices public records that chronicle areas where hazardous materials as defined in section 2 of chapter 21E of the General Laws of Massachusetts have been released and the status of remedial actions updated semi-annually until final response actions have been taken and thereafter maintain the record of such final response for a period of three (3) years.

(B) The Town will make available by publication on its web site and in one of its offices public records on motor vehicle collisions on ways within the Town updated semi-annually.

§ 147-12 Controls

- (A) The Town will post a sign on any of its property listed for publication under section 147-11(A) containing a summary of the published information.
- (B) Following each data update completed pursuant to section 147-11(B), the Town will review motor vehicle traffic rules, regulations and improvements for the purpose of considering amendments or additional improvements designed to alleviate the occurrence of future similar incidents.
- (C) No person designated as level 2 or 3 under the provisions of G. L. c. 6 § 178K(2) in whole or in part by reason of a sexual offense against a child shall take up residence apart from a person related by blood or marriage within the first degree of kindred within the Town within 1,500 feet of the boundaries of land containing a facility with the principle purpose of providing services to a child.
- (D) A person does not commit a violation of subsection (C) if any of the following apply:
 - (1) the person is required to serve a sentence at a jail, prison, juvenile facility or other correctional institution or facility; or;
 - (2) the person had already established residence as of the effective date of the prohibitions.

§ 147-13 Enforcement

Violations of Section 147-12 shall be punishable by a fine of \$300.00 per day.

§ 147-14 Severability

The invalidity of any section or provision of this Article shall not invalidate any other section or provision thereof. "

SECTION 2

The provisions enacted in sections 147-8-14 of Article IV of Chapter 147 shall take effect ninety (90) days following their adoption by the Town Council."

This legislative item, 2007-035, is a three pronged approach with the principal emphasis being to provide information to parents in easily accessible form on the town web site that (1) chronicles public information about areas where there may have been hazardous materials as defined by Chapter 21E of Massachusetts General Laws on public lands and where children are known to congregate, (2) chronicle public records on motor vehicle collisions and pedestrian safety in areas where children are known to congregate and (3) utilize information from the Barnstable Police Department Sex Offender Registry to identify possible sex offender residency.

In addition the item will cause procedures to be set up to post information about hazardous materials on town land, improve traffic design and oversee persons listed in the sex offender registry.

SUBJECT: Rationale for Historic Restoration of portions of the Unitarian Church

BACKGROUND: The Community Preservation Committee (CPC) met on July 18, 2006 and has recommended that the town support the funding request of \$19,620.00 from the Unitarian Church located in Barnstable Village.

RATIONALE: The Unitarian Church requires preservation work to reverse deterioration that is present in three key areas and to restore the original historical character. The first key area is to restore is the rear windows of the church. There are a total of 10 windows that have extensive rotting of the sills and molding. To ensure the historical character of the building remains intact, it is proposed that the windows are restored using a three party epoxy filler system. The process involves scraping and cleaning away old paint, injecting epoxy into the damaged areas, sanding and finishing the hardened epoxy to the desired shape, and then priming and painting the repaired areas.

The second area to restore is the access door to the side graveyard. The access door consists of an entrance porch, platform step and door. The door and the platform step are in need of the restoration work. There is massive deterioration to the door and the platform step is structurally unsound because of the rotting wood. This process involves removing the door to repair it and the platform step will be restored using new timber. Both of these repairs will bring this portion of the structure up to code with state and local building codes.

The final area to restore in the Unitarian Church is the library room. The restoration work will be on the walls and ceiling. Years ago a hanging ceiling was installed to hide the condition of the original plaster. This ceiling should be removed and the plaster ceiling should be restored to preserve the original character of the room. In addition, the walls are cracking and plaster is loose.

It will be necessary for a historic preservation restriction to be placed on the work that is done at the Unitarian Church in Barnstable Village.
