SUBJECT: Appropriation Order to Design and Construct Phase I of the New Permanent Main

Terminal Aircraft Parking Ramp

**BACKGROUND:** The construction of the new Passenger Terminal Building requires the installation of a new permanent Main Terminal Aircraft Parking Ramp area immediately in front of the new Terminal and to cover areas previously occupied by recently demolished buildings; and to enable continued aircraft parking, during and following completion of the new building. This project will include the design and installation of the new pavement, which will serve as Phase I of the project scheduled for FY2013 to complete the reconstruction of the entire Main Terminal Ramp.

**ANALYSIS:** The project is necessary to provide a new permanent aircraft parking ramp for continued access to passenger aircraft at the new terminal building following construction of the new terminal; and it must be designed as a permanent 20-year structure to qualify for Federal Aviation Administration (FAA) Airport Improvement Program (AIP) and Massachusetts Department of Transportation (MDOT) Aviation Safety and Maintenance Program (ASMP) reimbursable grant funds.

It became apparent while exercising prudent planning for construction of the new Passenger Terminal that the demolition of the former operations building and Terminal II needed to be completed 3 years ahead of previous plans associated with the design and construction of the new main terminal aircraft parking ramp project (previously submitted by Town of Barnstable Capital Improvement Program projects AIR-11-4 and AIR-12-11) in order to facilitate safe aircraft operations and passenger handling from the new terminal. The demolition was completed within the new passenger terminal construction project budget. Construction of the new permanent Phase 1 aircraft parking ramp will be capable of handling all current and projected aircraft using the ramp.

Bids for this project as a "temporary" 5-year ramp were included in the main terminal construction bids as Guaranteed Maximum Price alternates; however, they were not accepted due to funding constraints. In order to qualify for FAA and MDOT reimbursable grants, this project must be rebid utilizing Federal bidding requirements as a "permanent" 20-year ramp.

**FISCAL IMPACT:** This appropriation of funds will be sufficient to complete the project and there are adequate airport enterprise reserve funds available until reimbursed by the FAA at 95% and MDOT at 2.5% of total eligible costs. This appropriation will not be added to the base operating budget of the airport enterprise fund going forward.

**TOWN MANAGER RECOMMENDATION:** The Town Manager recommends approval of this appropriation order.

**BOARD AND COMMISSION ACTION:** Project approved by the Barnstable Municipal Airport Commission as an FY2011 Supplemental CIP and as part of the FY2011 FAA and MDOT ACIP.

**BACKGROUND:** The Department has been awarded a grant in the amount of \$6,000 to participate in the current round of *Drunk Driving. Over the Limit. Under Arrest.* and the *Click It or Ticket* mobilizations. This grant helps to raise awareness of both traffic safety challenges involving drinking and driving as well as the importance of seatbelt usage.

**ANALYSIS:** Acceptance of this grant will assist the Department in the continuance of these important traffic safety programs.

**GRANT DETAIL:** \$6,000 of the grant will be directed toward overtime associated with 3 mobilizations directed at specific concerns: *Click It or Ticket.* (1) and *Drunk Driving. Over the Limit. Under Arrest.* (2)

**FISCAL IMPACT:** This grant will supplement the currently allocated funds. There is a required match that will be satisfied using currently allocated department resources and in-kind matches.

**BACKGROUND:** On September 7, 2010, the Massachusetts Department of Transportation (MassDOT) Board of Directors voted to authorize the Secretary/CEO of the MassDOT to execute a Grant Award in the amount of \$13,083,900 to the Barnstable Municipal Airport, in a form approved by the MassDOT General Counsel, for certain costs related to the construction of a new terminal building, terminal area roadways and associated parking.

These Grant Assurances reflect the form as approved by the MassDOT General Counsel.

**FISCAL IMPACT:** A very positive and essential fiscal impact on the construction project. When the Grant Assurances are executed by all parties, the Grant Assurances shall be incorporated in and become part of the Grant without further reference, and shall remain in full force and effect for twenty (20) years from the date of receipt of funds for this project.

Execution of the Grant Assurances will allow the Airport Commission to request reimbursement of funds expended for the construction project.
