SUBJECT: Authorizing the Council President to Sign the Grant Assurances for \$401,588.00 awarded to the

Barnstable Municipal Airport

BACKGROUND: The Barnstable Town Council unanimously approved the following appropriation order for the design and construction of the project to reconstruct and realign Taxiway Alpha (A), construction of the main terminal ramp — Phase 2, construction of a new aircraft deicing pad, and other miscellaneous airfield improvements: Appropriation Order 2013-101 in the amount of Seven Million Eight Hundred Thousand Dollars and No Cents (\$7,800,000.00) on April 25, 2013 and authorized The Town Manager and the Town Treasurer to borrow \$7,800,000.00 to meet this appropriation to fund the project, with the understanding that the project would not proceed unless the grants were approved.

The Town Council also authorized the Airport Commission to contract for and expend the appropriations made available for these purposes and to accept any grants or gifts in relation thereto.

Based upon the results of a competitive bidding process, the final total project cost was revised to \$5,666,500.00 with a Federal Aviation Administration approved grant in the amount of up to \$4,819,057.00 covering 90% of "FAA eligible costs" under AIP Project Number 3-25-0025-058-2013. On October 22, 2013, the Massachusetts Department of Transportation (Mass DOT) Aeronautics Division authorized a Grant Award in the amount of \$401,588.00 to the Barnstable Municipal Airport, for 7.5% of the FAA eligible cost of this project under State Project Number HYATWA. After reconciliation, any remaining costs will be paid by the Airport Reserve Funds, including full payment of all FAA "ineligible" costs currently projected to be \$311,992.00. These Grant Assurances reflect the form as approved by the Mass DOT General Counsel. See Attachment A.

FISCAL IMPACT: A very positive and essential fiscal impact on the project. When the Grant Assurances are executed by all parties, the Grant Assurances shall be incorporated in and become part of the Grant without further reference, and shall remain in full force and effect for twenty (20) years from the date of receipt of funds for this project.

Execution of the Grant Assurances will allow the Airport Commission to request reimbursement of funds expended for the design and reconstruction and realignment of Taxiway Alpha (A), the aircraft parking apron Phase 2 and the deicing pad. The work on this project is scheduled to commence on February 15, 2014.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends approval of this Resolve.

SUBJECT: Authorizing the Council President to Sign the Grant Assurances for a Grant to the Barnstable

Municipal Airport

BACKGROUND: The Barnstable Town Council unanimously approved the following two appropriation orders for the design and construction of the project to upgrade and extend the life of the Runway 6 Engineered Material Arresting System on the departure end of Runway 24:

- 1) Appropriation Order 2012-090 in the amount of Eight Hundred Thousand Dollars and No Cents (\$800,000.00) on April 5, 2012 for the design and construction; and
- 2) Appropriation Order 2013-096 in the amount of Two Hundred Thousand Dollars and No Cents (\$200,000.00) on April 25, 2013 for additional construction funding required subsequent to a second inspection of the existing EMAS system; and authorized Airport Reserve Fund transfers in the total amount of One Million Dollars and No Cents (\$1,000,000.00) to fund the project.

The Town Council also authorized the Airport Commission to contract for and expend the appropriations made available for these purposes and to accept any grants or gifts in relation thereto.

A previous Appropriation Order 2011-075 in the amount of Twenty Thousand Dollars and No Cents (\$20,000.00) approved on April 7, 2011 was for the EMAS inspection and testing. This was the subject of a previously approved grant, and subsequently approved grant assurances.

Based upon a final revised total project cost of \$905,000.00 the Federal Aviation Administration approved a grant in the amount of up to \$814,500.00 covering 90% of this cost under AIP Project Number 3-25-0025-057-2013. On October 22, 2013, the Massachusetts Department of Transportation (Mass DOT) Aeronautics Division authorized a Grant Award in the amount of \$67,875.00 to the Barnstable Municipal Airport, for 7.5% of the cost of this project under State Project Number HYAEMAS. After reconciliation, any remaining costs will be paid by the Airport Reserve Funds. These Grant Assurances reflect the form as approved by the Mass DOT General Counsel. See Attachment A.

FISCAL IMPACT: A very positive and essential fiscal impact on the project. When the Grant Assurances are executed by all parties, the Grant Assurances shall be incorporated in and become part of the Grant without further reference, and shall remain in full force and effect for twenty (20) years from the date of receipt of funds for this project.

Execution of the Grant Assurances will allow the Airport Commission to request reimbursement of funds expended for the testing, design, and construction of the upgraded EMAS System, which was completed on November 9, 2013.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends approval of this Resolve.
