ORDER TO PETITION THE GENERAL COURT OF THE COMMONWEALTH TO ENACT SPECIAL LEGISLATION APPROVING THE CHANGE IN CARE, CUSTODY, MANAGEMENT CONTROL AND PURPOSE OF TWO PARCELS OF LAND, NAMELY A ± 16.3 ACRE PORTION OF TRACT I OF THE WEST BARNSTABLE CONSERVATION AREA SHOWN ON ASSESSORS MAP 86 AS PARCEL 1 AND A ± 17 ACRE PARCEL SHOWN ON ASSESSORS MAP 314 AS PARCEL 027001

ORDERED: That the Town Manager submits a petition to the General Court of the Commonwealth for a special act approving the change in care, custody, management, control and purpose of two parcels of land in the Town as follows.

"AN ACT AUTHORIZING THE TOWN OF BARNSTABLE TO TRANSFER TWO PARCELS OF LAND.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same as follows:

SECTION 1: The conservation commission of the town of Barnstable shall transfer the care, custody, management and control to the Town Manager for general municipal purposes of a certain 16.3 acre portion, more or less, of a larger parcel of land identified on assessors' map 5 as parcel 4, which was acquired by the town and held by the conservation commission for conservation purposes pursuant to section eight "C" of chapter forty of the General Laws and has been declared by the conservation commission to no longer be appropriate to be held by the conservation commission for such purposes. Upon the transfer as provided in Section 3 the Town of Barnstable shall be authorized to use the 16.3 acres, more or less, for general municipal purposes. The 16.3 acres more or less declared surplus in order to be transferred as provided in this section 1 are also shown on a plan entitled "Plan of Land in Barnstable (West Barnstable) MA Prepared for the town of Barnstable Prepared By: the Town of Barnstable -D. P. W. Survey Division Date: July 28, 2014 Scale: 1" = 80" on file in the office of the town clerk.

SECTION 2: To ensure a no net loss of lands protected for conservation purposes under section 1, the Town Manager of the town of Barnstable shall transfer the care, custody, management and control to the conservation commission for conservation purposes pursuant to section eight "C" of chapter forty of the General Laws of a certain 17 acre, more or less, parcel of land identified on assessors' map 314 as parcel 027001, which was acquired by the town and held for general municipal purposes and has been declared by the Town Manager to no longer be appropriate to be held by the Town Manager for such purposes. The parcel contains wetland, upland and other significant natural features as well as potential for passive

recreational use and is bounded on the Southeast by public water supply land. Upon the transfer as provided in Section 3 the parcel described herein shall be preserved as conservation land in accordance with said section eight "C". The 17 acres more or less declared surplus in order to be transferred as provided in this section 2 are further described as Lot 1 on plan of land recorded in the Barnstable County Registry of Deeds in Plan Book 417, Page 18 and was acquired by the Town by deed dated May 15, 1986 and recorded in said Registry in Book 5077 Page 300.

SECTION 3: The Town Manager may execute and record any instruments necessary on behalf of the Town to effectuate the transfers under sections 1 and 2 following passage of this act.

SECTION 4: This act shall take effect upon its passage.

BACKGROUND: On December 11, 2012 the West Barnstable Shooting Range was closed following notification from the Town's insurance carrier that the Town no longer had coverage under its existing policy. The Town commenced a multifaceted process involving the Massachusetts Department of Conservation Services (DCS), Barnstable Conservation Commission, Town staff and Town Council examining all aspects of reopening the shooting range. One issue that arose following a letter from DCS to Barnstable Conservation Commission on September 23, 2013 involved removing the range from 8C jurisdiction. Subsequent meetings between DCS, Barnstable Con Comm. Town staff and Town Councilors resulted in the Town proceeding with said removal.

ANALYSIS: It was recommended that the Town proceed with the process of removing the shooting range parcel (±16.3 acres) from 8C jurisdiction. The Conservation Commission voted to remove the shooting range from 8C on June 24, 2014. The Town Manager offers the 17 acre municipal parcel for placement under 8C in exchange (provided the use of the Breeds Hill parcel for the "swap" does require DCS review and approval). A two-thirds vote of the Town Council and both branches of the State Legislature are needed to remove the range parcel from 8C purposes. The Town Council would also need a 2/3 vote to change the purpose of the 17 acre parcel Breed's Hill parcel from general municipal purposes to §8C purposes.

FISCAL IMPACT: The fiscal impacts of this action are minimal and limited to associated administrative costs.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends that the Town Council approve the action proposed by this order.

BACKGROUND: The amount of \$71,911.00 from the CPA Open Space set aside will be used to repair and restore the Skate Park and the basketball courts at the Barnstable Community Horace Mann Public Charter School.

Community Preservation Committee voted unanimously on July 28, 2014 and recommends that the Barnstable Town Council support the request of the Recreation Division of \$71,911.00 from the Open Space set aside for the upgrade and restoration of the Skate Park and Basketball Courts behind the Barnstable Community Horace Mann Public Charter School, 165 Bearses Way in Hyannis, Map #309, and Parcels #008 & #254. The total budget for this project is \$213,931.00. This facility will provide recreational activities for 400 to 500 youth of varying ages from across the town. The Skate Park and Basketball Courts had fallen into disrepair from intense use and age of the facilities and is supported by a significant donation from an area business through the bargain sale of skate ramps for the park representing an over \$100,000.00 savings to the town. There are significant matching funds to offset this request including \$142,020.00 in Department of Public Works and Recreation Division staff funds and labor and \$20,000.00 in General Fund monies. This request fulfills several Community Preservation Committee criteria including a project in an underserved area, significant matching funds; this project has important cost benefits and ongoing maintenance of the facility.

SUBJECT: Constructing a new Barnstable Little League Baseball Field at Barnstable

Community Horace Mann Public Charter School

BACKGROUND: The amount of \$100,000.00 from the CPA Open Space set aside will be used to support the construction of a new regulation Little League Field at the Barnstable Community Horace Mann Public Charter School.

Community Preservation Committee voted unanimously on July 28, 2014 and recommends that the Barnstable Town Council support the request of the Barnstable Little League of \$100,000.00 of Community Preservation Act Funds from the Open Space set aside for the construction of a regulation little league baseball field behind the Barnstable Community Horace Mann Public Charter School, 165 Bearses Way in Hyannis, Map #309, and Parcel # 008. The total budget for this project is \$310,000.00. Barnstable Little League is a nonprofit organization that promotes youth baseball in our town and currently services 456 children in various divisions in its programs. This baseball field will replace one that was removed when the Hyannis Youth and Community Center was constructed. The location of this field will service the Hyannis area, a prime location for Little League activities. It will also enable the league to promote youth baseball tournaments at one location where ancillary services are readily available to support such competitions. There are significant matching funds to offset this request including \$75,000.00 from the Lyndon P. Lorusso Charitable Foundation and in kind donations from several sources. Barnstable Little League has committed to the perpetual maintenance of this facility. This request fulfills several Community Preservation Committee criteria including a project in an underserved area, significant matching funds; this project has important cost benefits and ongoing maintenance of the facility.

SUBJECT: Municipal Solid Waste Contract

BACKGROUND: The Town's long-term contract for municipal solid waste (MSW) disposal with Covanta (SEMASS) will conclude on December 31, 2014. In 2012, in anticipation of the contract end date, the Town joined a consortium of regional communities, led by the Cape Cod Commission, to negotiate a new contract with Covanta. The result of this process was the development of general contract terms and the emergence of a competitive entity for MSW disposal. The proposed contract has an initial term of ten years plus two five year extensions. The Town Council must provide authorization for the Town Manager to enter into contracts for goods and services in excess of three years

ANALYSIS: The DPW, after negotiating with both firms during the past year, has negotiated a long-term contract with New Bedford Waste Services (NBWS) of New Bedford, Massachusetts for the disposal of MSW, beginning on January 1, 2015. Some noteworthy provisions of the contract include:

- Significant cost savings over competitor (\$1.5 million over initial term)
- \$55.00 per ton tipping fee plus \$12.00 transportation
- Barnstable will benefit from a better deal negotiated by any other community on the Cape
- Town no longer will truck MSW to Yarmouth
- NBWS will reimburse Town for any MSW that must go to Yarmouth via packer truck
- All Town's waste and recyclables handled by one entity
- State of the art disposal and recycling facility
- More than 40 years' experience
- Contracts with 6 other Cape Towns
- Positive references
- Strong desire to work with the Town

FISCAL IMPACT: Funds have been appropriated in the FY15 budget to cover the proposed increase in MSW disposal costs. CFAC has confirmed that adequate funds are available in the FY15 budget. A sticker fee increase is anticipated for calendar year 2015 to generate revenue required to fund the increase.

TOWN MANAGER RECOMMENDATION

Town Manager Thomas K. Lynch recommends approval of the proposed long-term contract for MSW disposal.
