#### **SUMMARY**

SUBJECT: Appropriation and Transfer Order of \$4 million for the Capital Trust Fund

**BACKGROUND:** The Town of Barnstable's capital needs are many. The FY 2016 capital improvement plan included a capital needs list in excess \$72 million in General Fund requests over the next five years. The Town committed to funding \$15 million of this amount in FY 2016. Additional funding sources need to be identified going forward to continue to address the projects on this list. Excess General Fund reserves have been dedicated to the Capital Trust Fund previously and this request seeks to do the same. The Capital Trust Fund is used as a financial tool to accumulate resources that are used for financing the Town's capital needs. Transferring these funds will allow the town to fund a more aggressive capital program over the next 5 years.

**ANALYSIS:** Positive operating results for the fiscal year ending June 30, 2015 resulted in the growth of the Town's Free Cash as certified by the MA Department of Revenue. The growth in Free Cash was the result of unexpended appropriations and actual revenues exceeding budget estimates. The main components of the unexpended appropriations were from vacancy savings in personnel budgets across all departments. The main components in the excess revenue generated were from the release of excess overlay reserves for abatements and exemptions on property taxes, motor vehicle excise taxes and building permits. The Town's Free Cash was certified at \$13,949,203 on of July 1, 2015. This request is to transfer \$4 million of the amount into the Capital Trust Fund. By adding this amount to the Trust Fund it is projected that the fund could finance a total of approximately \$40 million over the next 5 years. This includes a combination of bond financed and cash financed projects.

**FISCAL IMPACT:** In accordance with Town Council policy, an amount equal to 4% of the General Fund's operating budget, net of transfers, must be set aside for extraordinary and/or unforeseen expenditures from its certified Free Cash balance. The remaining balance is available for appropriation subject to Town Council approval. The allocation of the savings account balances as of July 1, 2015 in concurrence with town policies and the revenue sharing agreement between municipal and school operations is as follows:

Town Council Reserve	\$5,689,766
Municipal Savings	\$3,702,279
School Savings	\$4,557,158
Total	\$13,949,203

The proposed transfer of \$4 million will be drawn from the municipal and school savings accounts (\$2 million from each). This will leave a balance in each savings account that represents approximately 4% to 5% of their respective operating budgets. Combined with the Town Council reserve of almost \$5.7 million, the total remaining balance in the general fund free cash account (\$9.9 million) represents about 6.8% of the overall general fund operating budget (more than 1.5 times the amount of the Town Council's reserve policy).

**TOWN MANAGER RECOMMENDATION:** The Town Manager recommends approval of the transfer order.

**ANALYSIS:** The Growth Management Department has been awarded a \$5,000 grant on behalf of the Hyannis HyArts Cultural District from the Massachusetts Cultural Council Cultural District grant program. **FISCAL IMPACT:** This grant funded project leverages funds from the Shanty program revenue, satisfying the required grant match. No general funds will be expended on this economic development program.

**ANALYSIS:** The Growth Management Department has been awarded a \$5,000 grant on behalf of the Barnstable Village Cultural District from the Massachusetts Cultural Council (MCC) Cultural District grant program. This grant is a new funding source from the Massachusetts Cultural Council and we are successful applicants in its first funding round.

MCC requires communities with more than one cultural district to propose projects that will take place in all districts. Barnstable has two cultural districts, Barnstable Village Cultural District and the Hyannis HyArts Cultural District.

The grant award will support a temporary, interactive art experience for visitors within the Barnstable Village and Hyannis HyArts Cultural Districts. The "Art Meets Nature" frame project will call artists to submit a creative "frame. The frames will then be prominently displayed in both cultural districts with suggestions to use the frames in their social media posts, including the project hashtag, and to upload images to the ArtsBarnstable Instagram and Facebook pages. Frames are expected to be in place by mid-May through October, 2016.

**FISCAL IMPACT:** This grant funded project leverages additional funds from Barnstable Village Cultural District fundraising through Cape Cod Art Association, satisfying the required grant match. No Town funds will be expended on this arts and culture program.
