

Town of Barnstable Town Council June 7, 2012

quorum being duly present, Council President Frederick Chirigotis called the June 7, 2012 Regular Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

The Pledge of Allegiance was led by President Chirigotis, followed by a Moment of Silence.

PUBLIC COMMENT

Al Baker suggested reading in all items and just holding those items that councilors want to discuss and passing the rest.

Jane Saunders protested treatment of Patrick Page.

John Julius cited the laws to be able to speak if aggrieved.

Robert Tucker stated Mr. Lynch has the qualifications

Brooke Styche from the teachers' association addressed health insurance. Pleased about RFP process, and hoped for a change of the 50/50 split.

Burt Russo said he has spoken the truth about his grievance. How do we get the council to act together to represent the people? .

COUNCIL RESPONSE TO PUBLIC COMMENT

Councilor Dagwan addressed Mr. Russo's grievance by stating we can't discuss legal matters. She was on the consultant group regarding a search for the manager – we looked at time constraints, money and other issues.

Councilor Cullum said to Mr. Russo, it is not our own voice but we have to weigh issues and vote for the best of the Town of Barnstable.

Councilor Canedy stated that we are legislators and do do some constituent service. In some cases the issues are legal matters and we cannot assist.

Councilor Norman, regarding 50/50 split, noted that we have had that for many many years and current employees work under that assumption. If we got no responses to job applications, then we would need to look at it, but he did not think we need to look at it now.

Councilor Tinsley said he did vote to offer Mr. Lynch the two- year contract. We may not have had a problem in hiring so far; but right now a family plan of health insurance will have more costs beginning July 1 – so that may bring a problem in the future. We might have to look at a different split.

COMMUNICATIONS FROM ELECTED OFFICIALS, BOARDS, COMMISSIONS, STAFF, Vice President Barton read statistics from Music Dept. from the High School. They had very high averages and accomplishments and she wished them and all seniors the best.

Councilor Tinsley announced upcoming Father's Day Car show on Sunday the 17th.

Councilor Rapp-Grassetti congratulated the Town on their new Arts District Designation, and said it appears that Barnstable Village may be the next area seeking a similar designation. She noted an upcoming Cotuit Historic event on Sunday. Also June 14th – first Kettleers game vs. Hyannis Harbor Hawks

Councilor Canedy announced the Mercy Otis Warren award is being given this year to Judith Warren Scarafile. She gave a description of her accomplishments and she congratulated her. She also congratulated Chief Robert Crosby for earning Fire Chief's accreditation. Canedy attended wastewater plan hearing and thought it informative and noted there is a lot of material available. Comment period open until June 16.

Councilor Dagwan also announced Saturday and Sunday there is a maritime festival. Chris Kehoe, noted there will be "bikes on ice" at HYCC on the same day as the Father's Day car show – it is free.

Councilor Norman said the Barnstable Senior Center will have an open house next Friday.

Councilor Daley stated that the West Barnstable Fire Dept will hold a chicken bbq this weekend; and on June 14th there will be a proper disposal of old flags on Flag Day.

Acting Manager introduced Dr. Mary Czajkowski, Superintendent of Schools. She said \$250,000 in scholarships was awarded to seniors, there were music programs, First Tee programs, prom and after-prom celebrations; Special Olympics program in pre-school to highlight recent activities. We have a lot for which to be grateful. There will be 408 students who will graduate on Saturday.

The School Dept. presented a level service budget. She identified four goals: student achievement; stakeholder feedback; retention and recruitment, and cost control.
