Rationale given by Lindsey Counsell, Chair of the Community Preservation Committee. The Hyannis Public Library is a truly historic building and important fixture in the town. Open to public comment

- Joan Kenny stressed the importance of public access to the Library, the footing is unstable and we hope to get this job done if the council will vote for it
- Esther Colby spoke on behalf of the Garden Club that has done a tremendous amount of work beautifying the Library property, have donated bicycle racks, and donated to the sprinkler system. Please vote for this upgrade.

 Carol Saunders, Director of the Hyannis Public Library, stated we are proud of our historic building. We have had visitors from all over the globe tour our Library building. We just need to keep it going. Saunders said she would appreciate the council vote to preserve our history.

ORDERED: That, pursuant to the provisions of G.L. c. 44B, the sum of One Hundred Twenty Five Thousand One Hundred Forty Three and NO/100 (\$125,143.00) Dollars be appropriated and transferred from the Historic portion of the Community Preservation Fund and the sum of Ten Thousand One Hundred Seventy Two and NO/100 (\$10,172.00) Dollars be appropriated and transferred from the Undesignated portion of the Community Preservation Fund; and that the Town Manager is authorized to contract for and expend the total amount appropriated, subject to oversight of the project expenses by the Community Preservation Committee, for the preservation of the historic Hyannis Public Library to include; document preparation, site work, building construction, sill replacements, window work, painting trim and storm windows, and rebuilding the chimney of the Hyannis Public Library located at 401 Main Street, Hyannis, Map/Parcel 326/013, to be secured by a historic restriction on behalf of the Town of Barnstable.
