TOWN COUNCIL FEBRUARY 7, 2013

quorum being duly present, Council President Debra Dagwan called the February 7, 2013, Regular Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

The Pledge of Allegiance was led by President Dagwan, followed by a Moment of Silence.

An announcement was made by President Dagwan regarding the meeting being televised live and questioning if anyone was actively taping the session.

Citizen Advisory Committee—An update on the Comprehensive Wastewater Management Plan

Philip Boudreau from the Citizen Advisory Committee updated the council on the Comprehensive Wastewater Management Plan.

- The ENF was completed and filed with MEPA and other agencies; and the committee received their comments and responded as well.
- This year they will further rank solutions to help improve and protect our water for the future. The costs will be enormous. The committee is looking at short, mid and long term goals.
- This will be a multi-decade event and be one of the largest projects the town has ever undertaken.
- There will be some short term goals including putting more properties on the sewer, as well as other ideas. Some mid-term goals should be easy, and some modest funding may be needed.
- Coordination with abutting towns will be essential. Mashpee and Sandwich will need to be on board with Barnstable on the west. Mashpee has been a willing participant, but Sandwich has not been responding.

- On the eastside Yarmouth has worked with Barnstable, but it has not progressed. There are many decisions to be made with all the towns.
- There is a state law that deals with fertilizers and the regulations must be implemented by January of 2014.
- We will be focusing on education for homeowners.
- As far as shellfish aquaculture we will be looking for expansion on this. Shellfish cleans the waters. If expanded it can slow the damage in the embayments.

Councilors asked various questions about:

Cape Cod Commission funding, discharge areas, publication of document, consolidation of water districts, abandoning and relocation of wells, and outfall pipe to name a few.

Attorney Boudreau was thanked for his almost 20 years of his involvement in this issue.

Ex. Director Elizabeth Wurfbain—Hyannis Business Improvement District Update

Director Wurfbain came forward to explain what the B.I.D. does in the village of Hyannis.

- o BID has a board of directors who are all business owners
- Makes priorities for the business plan
- #1 Safety is priority cut in half the homeless issue
- Hyannis Police Station visibility and perception
- #2 Clean grant to help keep street clean; beautification
- o #3 Marketing
- #4 Economic Development and Gov't Relations want to promote the process for businesses
- Value of the properties has doubled since the BID began.

Future? There is a moving plan – enhancing the summer but build up weddings and conferences in the shoulder and other seasons; looking to the future of the Armory.

PUBLIC COMMENT

Rick Barry gave an "At - a - boy" to the Barnstable Police Dept. for their good work in retrieving items from a break-in at his house, and apprehending the individuals involved.

COUNCIL RESPONSE TO PUBLIC COMMENT

Councilor Rapp Grassetti thanked Mr. Barry and thanked him for contacting the police.

Councilor Chirigotis thanked Mr. Barry as well – people feel violated when broken into. We should not tolerate it.

Councilor Cullum said there have been a lot of break-ins. She believes that it is due in large part to a drug problem in town.

A. OLD BUSINESS

2013-066 APPROPRIATION & LOAN ORDER--\$633,000 FOR PRIVATE ROAD REPAIRS INTRO: 01/17/13, 02/07/13

Upon motion duly made and seconded it was voted to go in to a public hearing for the purpose of discussing said item.

VOTE: 12 yes

Roger Parsons, Town engineer made the presentation on the private road repair program. DPW was petitioned by the residents. The roads are old – total set of roadways in a subdivision. They will go out for bid. There is overwhelming support from the residents for this.

Bob Stoultey (23 Burning Tree) – the support of the neighborhood (36 properties, 30 houses – 83.3% approval rate. If you take out the 6 empty lot – we have a 93.3% approval). Thanked councilor Daley.

Closed public hearing.

The cost of the project will be shared equally and they can pay over 10 years or in one lump sum. If taken over time there is a 5% interest charged. Dir. Milne said the 5% is charged under State Statute. Or we would charge 2% above what we would pay if we went out to borrow.

Councilor Daley asked if the betterment could be paid quarterly instead of yearly – we will work together to try to get the billing method changed. Dir. Milne – we are working with the software vendor to see if it can be changed...they are anticipating it may happen before these people pay. Yes.

Councilor Norman – thought the payments regenerated itself.....is it regenerating? The 10M is an authorization it is not an amount we borrowed. We borrow just the amount of money needed for the repairs –
