2014-040 AUTHORIZING A SNOW AND ICE OVERDRAFT ORDER FOR FY2014 INTRO: 11/21/13

Rational was given by Dan Santos, Director of Public Works, due to variable and unpredictable weather, MGL allow communities to make expenditures that are in excess of available appropriations. Since 2009 we budget \$600,000.00 for snow and ice removal last year we spent 1.6million.

2014 -041 ACCEPTANCE OF \$ 2,000 GRANT – FOR PURCHASE OF RECYCLING BINS FROM THE MASSACHUSETTS DEPARTMENT OF ENVIRONMENTAL PROTECTION INTRO: 11/21/13

Rational was given by Dan Santos, Director of Public Works-Small scale initiative grant for sustaining existing waste reduction programs, upgrade containers and provide more education outreach.

Upon a motion duly made and seconded it was

RESOLVED, that the Town Council hereby accepts a grant award in the amount of \$2,000.00 from the Massachusetts Department of Environmental Protection for the purchase of recycling bins and that the Town Manager is authorized to expend the grant monies for the purpose specified therein.
