

# TOWN COUNCIL MEETING April 4, 2013

quorum being duly present, Council President Debra Dagwan called the April 4, 2013, Town Council meeting to order at 7:05 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

The Pledge of Allegiance was led by President Dagwan, followed by a moment of silence.

An announcement was made by President Dagwan regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

• Special gift from Mrs. Irene Sears to the Bluecoats of Barnstable for the Barnstable Police Department: Chief MacDonald thanked Irene and Waldo Sears for the \$10,000 gift to the police department. The Bluecoats are a group of residents, and tax payers in the Town of Barnstable.

#### **PUBLIC COMMENT:**

Christine Greeley brought the Council up to date regarding the moratorium within Yarmouth on Medical Marijuana.

Dorothy Hughes asked questions about grinder pumps. The grinder pumps size, lifespan and who will repair them or replace them?

Charlie Hetsel appreciates the outstanding job of taking care of the roads recently. He has concerns about Stewart Creek and the costs associated with the grinders.

Jane Saunders stated the settlement offered to our property is a cruel joke. Jane said she and Patrick met with a new lawyer assigned to them in October. Jane said he was to get back to them in 4 to 6 weeks. They never had a meeting again until well after Christmas. After 5 months we were offered a nuisance payment of \$5,000.

John Julius stated he is disappointed in the Council, restricting us to two minutes. There will be a lawsuit against the Stewart's Creek fiasco. Stick it to the homeowners, if you don't want to listen to the residents, you will be facing us in court.

Laurie Brown speaking on the Stewart's Creek betterments, regarding the per parcel per property, which is different than dwelling units. She asked the Council to help us out and thanked them for listening.

## COUNCILOR RESPONSE TO PUBLIC COMMENT:

Councilor Canedy said we are available to talk with the residents. Tonight we can't spend five or ten minutes for each public comment due to the heavy agenda.

Councilor Cullum said if you talk nicely to me I will respond.

Councilor Joakim stated there has to be a balance between letting people speak and having time limits. Council approved \$220,000 for an Accessory Affordable Housing Project, not for a 40B.

Councilor Rugo asked the Town Manager about the questions relative to the sewers and the grinders, and where does the tax money from the hotel and local option go.

Town Manager, Thomas Lynch said the tax monies from the local options go into a separate Sewer Trust Fund just to be used for waste water protection and sewering issues. Grinder pumps are being provided by the town. We now have one point of contact available to the residents for questions regarding Stewarts Creek, call Len Gobiel. Councilor Canedy asked is there relief afforded to newly installed title 5 system? Yes, the resident should contact Mr. Gobiel regarding relief.

David Kenyoth, Facilities Director, went through a slide presentation describing the improvements needed for the roof and the façade of the intermediate school, United School grades 4 & 5 Roof and Trim Replacement (Exhibit A)

The lifespan of a new roof is about 30 years; the original construction company was not at fault. No claim was tended as it was a design error and they are no longer in business. After Council acceptance of this item the school will apply for the approvals. The award from the state will reduce the amount owed to complete the projects. After the project is finished we can revisit solar collectors on the new roof.
