

Town Council Meeting December 4, 2014



quorum being duly present, Council President Jessica Rapp Grassetti called the December 4, 2014, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Rapp Grassetti regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

Thomas Lynch introduced DPW Director, Dan Santos to give an update on the Solid Waste Transfer Station sticker.

- Cost will be \$210.00, however the sticker is good for 18 months (until June of 2016)
- Single stream recycling will begin on January 1st

Councilor questions and comments:

Regarding sticker prices, how does that effect summer visitors [second homeowners can qualify] the \$210.00 is for 18 months but will the cost of the sticker be \$210.00 next year [we do not know as yet, we will have to reevaluate] Can we purchase a sticker prior to January 1st [we will notify you as soon as they are available] If we find that some recycle items would bring in revenue if we can market them ourselves, will we be able to exclude certain items [yes] what if someone doesn't purchase a sticker and wants to drop off a bag or two of trash [Per visit is \$15.00] Where does one purchase a transfer station sticker [at the Transfer Station] Will the residents have to have two different stickers [no]

Councilor questions and comments: One of the things you may want to look at is the dingy situation; how would you like to see your roll redefined; [we were not told there was going to be a new sticker for the Transfer Station or a price change] posting of the minutes on the website is very important [oversight in changing of the Secretary] always more room for citizen advocacy could you go to the Civic Associations to provide a voice for the citizens [the Public Works Commission should seek out Civic Associations] Dan Santos is a super hire; the role has changed for the commission; we need to focus on a way for you to fulfill your role; should start with us here on the Council.
