

Town Council Meeting April 16, 2015



quorum being duly present, Council President Jessica Rapp Grassetti called the April 16, 2015, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

Source of money in the airport enterprise fund [generated from revenues collected, every year we put reserves into the enterprise fund] is all of this money coming out of enterprise funds or is some coming from a bond [Mark Milne, Director of Finance replied not bonded yet, because the project hasn't started] have you had any indication that other tanks are leaking [field farm is strictly for jet fuel] all of the underground tanks will eventually need to be replaced, and are not part of this project [yes] walk through how fuel is handled; do we have a vendor that off loads into these tanks; then an employee fills up the smaller trucks to then fuel the jets [yes, we have different sized refueling trucks] right to sell gas, clarify any pending issues [no pending issues we retain the exclusive rights to sell jet fuel] major construction time frame [we will be doing both at the same time-3 month construction project] oily water separator is that an MDC trap; back up power [small back up generator]

Sturgis library is Barnstable Village's community building; using a variety of funding resources; clarification is this a town building and the library pays rent? [No, the library owns the building and the land] control of materials; do you monitor the archives; do you make visitors use cotton gloves [have to sign in, give up their coats and bags, use pencils only]

Upon a motion that was duly made and seconded it was

ORDERED: That, pursuant to the provisions of the Community Preservation Act, G.L. c. 44B, the sum of Two Hundred Fifty Thousand and NO/100 (\$250,000.00) Dollars be appropriated for preservation of the historic resources of the Sturgis Library consisting of important collections of Cape Cod history, genealogy, and maritime materials in New England, documenting the history of the Village, Town, and County of Barnstable from the early 1600s to the present day by replacing archival storage space and the current HVAC system, both of which are needed to house and protect their unique and important historical collections; and that to meet this appropriation that \$154,000 be transferred from the amount set aside for historic resources in the Community Preservation Fund and that \$96,000 be transferred from the undesignated amount set aside in the Community Preservation Fund; and that the Town Manager is authorized to contract for and expend the appropriation made available for this purpose subject to the oversight of the Community Preservation Committee.

COUNCILOR QUESTIONS AND COMMENTS:

The vote coming out of committee was not unanimous; expense could be justified with receipts or may take it as a lump sum; thanked the committee and leadership; supported this but will not be a recipient; expenses for a Councilor can be very costly; voted against an increase, certain expenses vary by Councilor; won't support this tonight; travel to meetings to represent the Council; costly to attend various meetings; like the idea of increasing the expense account; this will always be a news item; have to make choices on it; seems foolish not to look at this that allows Councilors to support their constituents; all Councilors should have the ability to attend functions, get more education and to participate more fully; extra funding for others who may run for the Council.

There will be an expense allowance for Town Councilors and the Vice President of \$2,200 per year, and for the President, an expense allowance of \$2,800 per year."
