

Town Council Meeting May 7, 2015



quorum being duly present, Council President Jessica Rapp Grassetti called the May 7, 2015, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

COUNCILOR QUESTIONS AND COMMENTS:

Why didn't this work, is it for a lack of clients? [Maddie Noonan stated last two years cost to run the program became too high, fee increase didn't offset the expenses] Sad to see it go, thank you for the information; was this a pay as you go, or have you considered a six month fee [elderly income is difficult, we would have priced people out] have you looked at Grant opportunities [yes, we have, traditionally grants do not cover staff payroll] Can we take a look at keeping the program, for fewer clients, and less staff? Would need a program like this for our seniors.

2015-071 AMEND ZONING ORDINANCE, ARTICLE III. DISTRICT REGULATIONS, § 240-39 SHOPPING CENTER REDEVELOPMENT OVERLAY DISTRICT (SCROD) AND AMEND THE ZONING MAP AS SHOWN ON THE MAP ENTITLED SHOPPING CENTER OVERLAY DISTRICT AMENDMENT FEBRUARY 20, 2015 INTRO: 02/26/15, 05/07/15

Attorney Michael Ford gave the rationale outlined the history of this land. Jo Anne Miller Buntich read the Planning Board letter of support for the record (original on file in the Clerk's office)

COUNCILOR QUESTIONS AND COMMENTS:

This is an economic opportunity; this ordinance returns this area to what it was; we know the 100 foot setback needs to be revisited; will support it; what about the traffic patterns; where would the entrance and exits be [premature to discuss at this point] this is the first step, traffic will be discussed later on; everyone has the opportunity to make comments; this is consistent with the area; happy to support; identifies the look of Route 132 to Route 6A, trying to be business friendly; traffic issues will be covered in the next steps; sponsor this project; make it workable; want to be business friendly area; businesses that work for everybody; this will bring more year round jobs; what is the timetable [20 day period, before we go forward] this is not a done deal at this point; biggest concern; keep open for mixed use; at the end of the day this is a good decision.

Upon a motion duly made and seconded it was

ORDERED: Section 1. That the Zoning Ordinance, Article III. District Regulations, Sec.240-39 Shopping Center Redevelopment Overlay District, Section F. Permitted and prohibited uses, is hereby amended as follows:

By adding the following language to the end of Section 240-39.F (2) (f):

"and a drive-through restaurant may be permitted only on that area within the SCROD identified as "Drive-through Restaurant Sub Zone" as shown on the Map entitled Shopping Center Redevelopment Overlay District Amendment dated February 20, 2015 subject to the special permit provisions of sec. 240-39M"

So that as revised subsection (f) shall now read:

"(f) Drive-through restaurant or drive-through bank, except that a drive-through bank shall be permitted in so much of the Shopping Center Redevelopment Overlay District as lies within the Highway Business District, subject to the special permit provisions of Sec. 240-39M, and a drive-through restaurant may be

permitted only on that area within the SCROD identified as "Drive-through Restaurant Sub Zone" as shown on the Map entitled Shopping Center Redevelopment Overlay District Amendment dated February 20, 2015, subject to the special permit provisions of sec. 240-39M."

Section 2. That the Zoning Ordinance, Article III District Regulations, Sec. 240-39, Shopping Center Redevelopment Overlay District, Section M Special permit provisions, is hereby amended as follows:

By adding the following phrase to the last sentence in Section 240-39.M (1) (a) after the words "drive through-bank":

"or drive-through restaurant"

So that as revised subsection (a) shall now read in its entirety:

"(a) No building permit or occupancy permit shall be issued for any expansion of a regional shopping center which increases the gross floor area of the regional shopping center above that existing on the effective date of this § 240-39 by more than 50,000 square feet of gross floor area unless the Zoning Board of Appeals has issued a special permit approving such use in accordance with the provisions of this § 240-39M. In addition, no building permit or occupancy permit shall be issued for a drive-through bank or drive-through restaurant unless the Zoning Board of Appeals has issued a special permit or a modification of a special permit issued under this section, approving such use, subject to the provisions of this sec. 240-39M."

Section 3. That the Zoning Ordinance, Article III District Regulations, Sec. 240-39. Shopping Center Redevelopment Overlay District is hereby amending Section 240-39.G (1) (e) as follows:

By adding the following phrase at the end of subsection (e) [1]:

"except fifty (50) feet along that portion of Route 132/Iyannough Road on that area within the SCROD identified as "Drive-through Restaurant Sub Zone"

So that as revised subsection (e) [1] shall now read:

"[1] One hundred feet along Iyannough Road/Route 132 Road except fifty(50) feet along that portion of Route 132/Iyannough Road on that area within the SCROD identified as "Drive-through Restaurant Sub Zone"

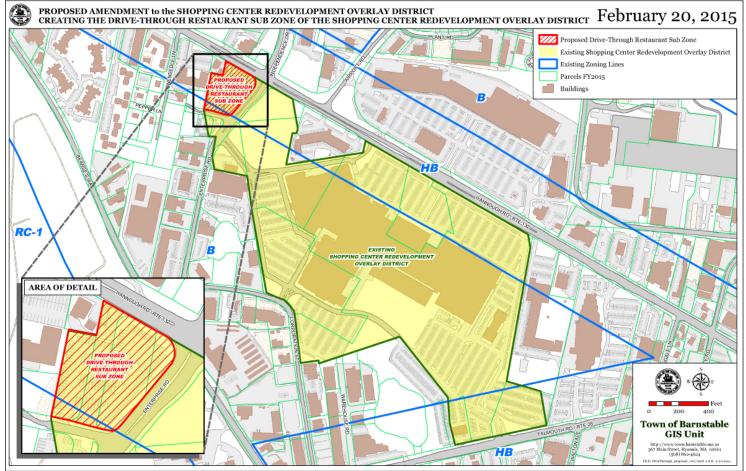
Section 4. That the Zoning Ordinance, Article III. District Regulations, Sec. 240-39 Shopping Center Redevelopment Overlay District, Section K. Signs in Shopping Center Redevelopment Overlay District, is hereby amended as follows.

Inserting a new subsection (12) to read as follows:

"(12) In addition to the signs permitted under Section 240-39.K (1) hereof, one freestanding exterior sign shall be permitted on that area within the SCROD identified as "Drive-through Restaurant Sub Zone" provided the Maximum height of freestanding signs does not exceed 12 feet above grade and the Maximum area of the freestanding signs does not exceed 50 square feet per side, exclusive of the structure holding the sign."

And further Under Section K by renumbering existing subsection (12) to "(13)".

That Chapter 240, Article II, Section 6, The Zoning Map of the Town of Barnstable Massachusetts, the Shopping Center Redevelopment Overlay District (SCRDO) is hereby amended to identified that area within the Overlay District as "Drive-through Restaurant Sub Zone" as shown on the Map entitled: "Proposed Shopping Center Redevelopment Overlay District Amendment dated February 20, 2015"

Can you give an explanation of additional monies for the sidewalk where will they be; [will probably be on the west side of the road, to get people off the road; catch basins] How long will the sidewalk be [900 feet] we need parcels which increase our access to the water; great idea. Corner of Route 28, needs some available space for parking; landscaping to match up with the community; if we remove the hill for a parking area, could we use the soil for the ball park that needs it; what we are talking about is the purchase of a parcel tonight, the rest of it can wait.

Dan Santos, Director of Public Works gave the rationale

COUNCILOR QUESTIONS AND COMMENTS:

Plan to support this; talked through the process undertaken to get this far; understand this project has to be done; did you pause to review the bids; why did you accept the lowest bidder of 4 bids; where was there an opportunity to review the bids and come to the Council; why hadn't the work begun when it was scheduled; how is it that how we have \$170,000 dollars sitting in an operating budget; how does that happen; [DPW has a significant salary budget; positions that go unfilled, workman's comp, injuries; various reasons why we do not spend the entire amount IMark Milne-the money falls back to the general fund surplus to replenish the reserves, we budget for full salaries] [Dan-the bidding process, lowest bidder met all the requirements of the bid request; which compels us to go with the low bidder; when the lowest bidder would not sign the contract we went to the next bidder] fast moving process; storms necessitated that this move along; emergency procurement when negotiations failed; at a recent FEMA event the participants were told that the towns can apply for relief due to the storms; advised by FEMA/MEMA money spent on clean up of the pilings and harbor may be recoverable [if there is an opportunity, for the aftermath, we are ready for submit that information] expanded the window of opportunity for reimbursement, and type of things recoverable; constituents still calling about town owned roads not fixed yet; upset this money is going to pilings when their roads have pot holes; the Councilors need to be advised before articles go into the newspapers; please communicate to us before hand; in the future if there is an opportunity to pause, please do that; we are required to take the lowest bid [this was an emergency, we did not have an opportunity to step back] at the time of the original appropriation the low bidder did not have to mobilize; not ideal; hope you support it

2015-146 <u>EMERGENCY MEASURE</u> TO AUTHORIZE BORROWING AND THE EXPENDITURE OF UP TO \$744,000 TO INSTALL A CARBON FILTER TREATMENT SYSTEM AT THE MARY DUNN WELLFIELD

Ruth Weil, Town Attorney explained the Emergency Measures provision of the Charter

Upon a motion that was duly made and seconded it was

ORDERED that:

SECTION 1. EMERGENCY PREAMBLE

Pursuant to Section 2-8(b) of the Charter of the Town of Barnstable, it is hereby declared that an emergency exists based upon the results of recent EPA-mandated testing of the Hyannis Water System for Contaminants of Emerging Concern which has identified the presence of per fluorinated compounds in the Mary Dunn Well field that exceed the Federal Health Advisory for these compounds. Working with the Massachusetts Department of Environmental Protection two of the wells in the Mary Dunn well field will remain out of service until an acceptable solution is in place.

As to the scope and nature of the emergency, the Mary Dunn wells are vital to the Hyannis Water System to be able to meet the drinking water and fire flow demands of residential and commercial customers in Hyannis, Hyannisport, and West Hyannisport, including Cape Cod Hospital. With the Mary Dunn wells off-

line, there is a strong possibility that we will not be able to meet the peak water demands of the summer season.

DPW proposes to install two portable granular activated carbon treatment units at the well locations to remove the contaminants from the water. It is imperative that the Town undertake, without delay, the procurement process to engineer, order, and connect the carbon units. The lead time for the carbon units is 4 weeks from the placement of the order for fabrication and delivery. Upon receipt of the units, connections have to be constructed as well as testing and performance monitoring before they can be brought on-line.

DPW seeks the invocation of emergency measures in order to obtain Town Council authorization to borrow and expend funds for the purposes specified above.

Noah Hoffenberg questioned are you seeking to have full reimbursement or do you already have it? [Seeking it, water supply needs to be safe for all users]

COUNCILOR QUESTIONS AND COMMENTS:

Nothing more important than our water systems; we are going to pinpoint the area of contamination; will all flows be tested [Yes] will it be possible to correct the issue once the site is identified [yes we remedial action can take place]

Close public hearing

Water supply is safe; we are being proactive; it is very important; we are not assigning blame at this point; that is premature and beyond the focus of tonight; source investigation is down the road; we are being proactive and safe at this point; [the action that is in our control we are taking at this point] the emergency is the flow which would be inadequate with the summer coming; COMM has link to the Hyannis water system, could that valve be opened, or are there other alternatives; [we have looked at other all viabilities; the best one is connected to Yarmouth; we are in discussions with Yarmouth; until I have that agreement with Yarmouth, we need to go forward]

SECTION 2. That the sum of up to \$744,000 be appropriated for the purpose of installing a carbon filter treatment system at the Mary Dunn Wellfield; and that to meet this appropriation, that the Town Treasurer, with the approval of the Town Manager, is authorized to borrow \$744,000, and that the Town Manager is authorized to contract for and expend the appropriation made available for these purposes.

SECTION 3. That this appropriation shall take effect immediately upon its passage as authorized under Section 2-8(b) of the Town Charter. .

Mike Grossman has questions about High Street and how it became a private road; is there a procedure to going forward to becoming a public road?

Gay Black stated her concern about some of these roads being dubbed private, when do they revert back to public, when did they become private; can you explain that?

Close public hearing

COUNCILOR QUESTIONS AND COMMENTS

Mix ownership/use down the whole length of the road, the deed to the properties indicates the title to ownership of the roads; some have private and public sections; it is not unusual to have this situation; public access roads are used heavily; did we discuss the criteria involved; [yes, connector roads, support high traffic; numerous vehicle damage complaints] Roads Committee will be discussing the idea of taking the roads; how the roads were classified; submit to the legal department your proof that the road is a town road; we do not know as yet where it will end; we will be taking those items up-to begin the discussion; can someone address if High Street ever town owned; [years ago the town did take care of the roads that were private roads; today it is just emergency repairs and snowplowing] High Street was the main road at one time in the 1800's; developers when selling homes in the area, improved the road; once Route 6A was built, they abandoned High Street; High Street is private road and an ancient way; thank you to the Roads Committee and staff to allow us to fix these roads using public funds. Many people do not know whether or not their street is private or public; on the town's website there is a draft map of the streets/roads which shows private or public; would like to ask the Town Assessor to add a notation to the parcel of land to indicate if the road is private or public; private roads put in by contractors many times [many ways that they can be private roads, needs to be proof that the town had deeded rights to the road] connector roads are used by local and commercial traffic; the criteria for the amount of trips over the roads used [number of trips per day-750 per day, Mary Dunn has documented 6,000 trips per day]
