



Town Council Meeting  
April 7, 2016



**A** quorum being duly present, Council President Jessica Rapp Grassetti called the April 7, 2016, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Rapp Grassetti regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Rapp Grassetti, followed by a moment of silence to remember the family of Royston Nash.

**PUBLIC COMMENT:**

Victor Skende, a Commissioner of the Hyannis Fire District, spoke about the need for a new Fire Station in Hyannis, please come out to vote.

Peter Cross, a Commissioner of the Hyannis Fire District, reminded the Council of the thousands of people who are served by the Hyannis Fire District, encouraged everyone to come out to vote.

**COUNCIL RESPONSE TO PUBLIC COMMENT:**

Councilor Hebert foresees that someday the Hyannis Fire Department will be the Municipal Fire Department, and he hopes everyone votes positively.

Councilor Tinsley encouraged residents to get out and vote, look at the plans on the website. Over 7,000 calls last year; time to support the men and women of the Hyannis Fire Department.

Councilor Dagwan this is a workable amount of money for our new fire station; the HYCC deals with hundreds of children daily; positive support by some Council members.

Councilor Cullum encouraged everyone to reach out to the Fire Commissioners to look at the number, this is an investment in our community; hope to see you on Saturday, I will be voting yes.

- **Report from the Comprehensive Financial Advisory Committee (CFAC).** Cynthia Crossman highlighted the committee's recommendations and noted that several of our passed recommendations have been adopted. Recurring projects should be looked at as an operational budget. Private roads repairs needs to have a program that is more consistent, in place of the two tier system with private roads, where some residents pay for the repairs and others do not. Feasibility study to look at the aging buildings, such as the Police Station.

Councilor Flores gave an overview of the Town Manager Screening process noted that five very good candidates have come forward; President Rapp Grasseti thanked the committee for keeping up with the time line; Councilor Cullum reminded everyone of the teen achievers banquet at the HYCC May 12<sup>th</sup>.

Councilor Hebert made a motion to waive the Town Council Rule 6F Reconsideration regarding the reconsideration of a vote taken at the March 24, 2016 meeting. The motion was duly made and seconded and it was followed by a **Unanimous Vote to waive 6F.**

Elizabeth Hartsgrove, Supervisor of Consumer Affairs gave the rationale using a power point program (Exhibit A), using the Town Council Goals of Quality of Life; Finance; Economic Development; Regulatory; and Public Safety.

What are Club licenses? [for private clubs such as a yacht club] Are there limits to the number of Wine and Malt licenses, [no] What is the rationale for an Inn Holder; Operating a special event without filing; [local establishment will have a special event without requesting any permitting, which impacts many departments] this chart shows some substantial increases have you done analysis [fee structure in place since 2009, checked rates with all 351 cities and towns] is this a valid request; what was the rationale of going to \$14 instead of \$20 [in keeping with today] weights and measures is that keeping in line with what they would be charged [yes] fully support analysis of town hall parking lot; when scale is off, we put the person out of service; but for a few dollars we can fix it for you, could we become liable [these were identified during the annual inspection period, a yearly requirement that all scales must be certified] a town employee is doing the adjustment, that should not happen, the business owner must assume the liability; not comfortable with the fee going to \$40; my opinion is we are becoming a business, never should make more money than the cost of service; licensing for legal ads must go to the true cost of the fee; change art galleries to arts; for private parking lots lets look at \$13.00 not \$14.00; [special events we do not recover the costs] support the numbers if they reflect the actual costs; competing with a small business isn't something we want to do; special event permitting, how is that working [more teamwork, on line form; website for special events]
