

Town Council Meeting October 5, 2017



quorum being duly present, Council President Eric Steinhilber called the October 5, 2017, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Steinhilber regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Steinhilber, followed by a moment of silence.

PUBLIC COMMENT:

Adam Hansen discussed pot shops and he explained his support of this type of shop. He felt if the pot shop were regulated and paid taxes then the criminal element would be eliminated.

Kimberly Chandler spoke about the conditions at Adams Court, 200 Stevens Street Hyannis and refuted the account from Maryann Barbosa who previously on September 28, 2017 stated the problems to the Council regarding the Barnstable Housing Authority (BHA). Ms. Chandler handed the Clerk a signed petition with 19 residents' names. (Exhibit A)

• Presentation by Erich Stephens, Vineyard Wind

Erich Stephens, Chief Executive Officer from Vineyard Wind, gave an overview of the PowerPoint presentation. He explained the energy transfer process and installation. He discussed the turbines and where his company was allowed to locate them. He noted the offshore wind farm would be 33 miles from Barnstable and 13 miles from the Martha's Vineyard and the Nantucket islands. He mentioned there would ultimately be 200 turbines on the company's ocean site.

Councilor Comments and Questions:

How many megawatts will be created by the windmills (7-9 megawatts with 100 turbines). How many homes will receive power? (About 275, 000 homes) Will the turbines have a negative impact on the fishing environment? This liability needs to be addressed in writing we need to make sure the fishing economy in Barnstable is not affected.
