#### TOWN OF BARNSTABLE NOTICE OF FUND AVAILABILITY (NOFA) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

**HYANNIS, MA** – The Town of Barnstable Planning and Development Department (PDD) is accepting proposals for the 2018 Community Development Block Grant (CDBG) program year (estimated July 1, 2018 – June 30, 2019). CDBG is a federally funded program from the U.S. Department of Housing and Urban Development (HUD) to provide affordable housing, economic opportunities and a suitable living environment to low and moderate income residents.

Projects must address at least one of the goals of the 2015 – 2019 Five Year Consolidated Plan: creation or preservation of affordable housing units or economic opportunities; improvements to public facilities, infrastructure or other public improvements; or provision of services to low income and special needs populations including but not limited to homeless persons. Proposed projects that address the goals in the Downtown Hyannis Neighborhood Revitalization Strategy Area (NRSA) defined in the consolidated plan may be given preference.

Estimated available total funding is \$283,342 plus any carry over funds and program income. This estimate is based on last year's funding levels and will be adjusted when final amounts are known. The amount available for Public Service activities is limited to 15% of the actual allocation estimating about \$42,000.

To be considered, Letters of Interest must be received in the Planning and Development Department by **4pm on February 28, 2018**. Please follow the Letter of Interest Instructions on the Town website [www.townofbarnstable.us/CDBG](http://www.townofbarnstable.us/CDBG) and refer to the CDBG Application Guidebook for more details on the process and eligibility requirements.
