**BARNSTABLE RECREATION DIVISION  
FEE SCHEDULE/POLICIES OF RECREATION FIELDS**

1. A seasonal permit is required for user groups utilizing any field.
2. Fees are assigned seasonally by the number of days per week a group utilizes a field. (\$50/game and \$500 for 10 or more uses per season).
3. Permits are only valid for the dates assigned to group.
4. When the Division requires a police detail, the incurred fees are the responsibility of the permit holder.
5. Permit length of time on the field will not exceed three hours. If so, group will pay additional fees.
6. The group leader/permit holder must be a Barnstable taxpayer/year round resident.
7. Permits will not be issued until the application has been completed, submitted, and approved by the Director.
8. Group leaders are responsible for the field/facility cleanliness and the actions of the group's participants. Any damages caused are also the responsibility of the Group leader.
