Amanda and Michael DeFazio have applied for a Comprehensive Permit to convert 450 square feet of area to a one-bedroom accessory affordable apartment located in a detached structure on the same lot as the principal dwelling. The subject property is addressed as 225 Old Falmouth Road, Marstons Mills, MA as shown on Assessor's Map 099 as Parcel 058. It is zoned Residence F.
