Meeting was called to order at 8:35 a.m. Roll call taken.

<u>F04/09-02</u> <u>Review Jacobs Consultancy for Business Plan/Proforma.</u> Airport Manager

Breault said he would be negotiating with Jacobs Consultancy to conduct the financial analysis proforma. The PFC FAA Application, if desired, will be

negotiated separately.

It was unanimously voted by the Finance Subcommittee to recommend to the Full Commission to hire W. Daniel Ochse of Jacobs Consultancy to prepare a Financial Review as proposed in his letter of March 27, 2009.

<u>F04/09-03</u> Review proposed Horsley & Witten's Scope of Work to Prepare a Strategic Plan and Obtain a Development Agreement with the Cape Cod Commission.

Resolve needs to be amended as required by the Town Council to have a revised date of completion that coincides with the Cape Cod Commission's requirements under the DRI.

It was unanimously voted to recommend to the Full Commission to hire Horsley& Witten to prepare the Development Agreement in compliance with the Cape Cod Commission DRI.

F04/09-04 Review proposed Horsley & Witten's Scope of Work to Complete runway Visibility Zone Tree Clearing.

- Moved to take under advisement.
- Will be discussed at May meeting.

The Airport Manager gave an update on the OTA; a letter was sent to the FAA on April 6, 2009 requesting that the revised OTA be approved by the FAA and be returned to the Barnstable Municipal Airport Commission for approval; an extension of time for construction was requested; and if the OTA is approved, we would immediately commence the AFTC tower siting process, readvertise for a new designer since over three years had passed and their August 2008 proposal was not compliant with the RFP, and we would commence the permitting process.

Manager Breault was asked the following:

- to inquire of Massachusetts Aeronautics Commission if the Barnstable Municipal Airport was in line for a stimulus package;
- to provide information to the finance subcommittee regarding any local share for the MacGregor property; and
- to submit an updated and revised CIP.

Adjournment: Voted and moved to adjourn at 8:50.

It was noted following adjournment that implementation of CFC's was deferred from April 1, 2009 to July 1, 2009 due to delays in the terminal construction.
