MEETING MINUTES

Chair of Committee Councilor Jeffrey Mendes opened the meeting of the Appointments Committee in the Selectmen's Conference Room at 3:00pm and made the following announcement:

Chair of the Committee asked for any Public Comment: Larry Morin just observing for now, may have comments later.

Councilor Terkelsen proposed improvements to the board appointment and reappointment process, emphasizing the need for fairness, transparency, and diverse representation. She suggested removing 13 committees from the list below due to concerns about their performance and proposed that this process should be handled by an ad hoc committee. Councilor Terkelsen also highlighted the importance of streamlining committee work and ensuring fair assignment of roles. The team agreed with her points, and concerns were raised about future reappointments within these committee. Councilor Clark addressed the attendance records of various commissions and boards within the organization, highlighting concerns about the frequent absences of some members. She suggested that the Appointments Committee should evaluate underperforming members before making decisions on reappointment, but it should not be their responsibility to remove members. Councilor Clark also proposed a new approach for handling committee members who miss meetings, suggesting that each case should be examined individually, taking into account any extenuating circumstances. She emphasized the importance of recognizing and appreciating the volunteers' efforts and encouraged more people to consider getting involved. Councilor Clark led the discussion on the change in the process of managing these Ethics and Open Meeting Law certificates, now handled by the State, and the implications for future appointments.

The Committee members agreed to start voting on the reappointments after the 13 were removed starting with the regulatory boards. Councilor Clark asked the Administrator to compile a list of these committees for review and potential interviews for reappointment.

Councilor Burdick proposed reforms to the committee appointment interview process, aiming to standardize questions, streamline the process, and enhance its effectiveness. He suggested focusing more on understanding the candidate's personality and temperament, rather than their stance on specific issues, and recommended limiting repetitive and potentially litmus test questions. Councilor Burdick also recommended a time limit for each individual's input in ad hoc committee meetings, to keep discussions concise and to the point. He emphasized the importance of maintaining a professional, municipal, and non-political approach to the board's role in evaluating candidates.
