Call to Order:

Notice of Recording: With a quorum present, Chair Lindsey Counsell called the meeting to order at 7:00 pm and read: "Please note that tonight's meeting is recorded and broadcast on Channel 18 and, in accordance with MGL Chapter 30A, s.20, I must inquire whether anyone else is recording this meeting and to please make their presence known." No one present was recording the meeting.

Minutes:

 Approval of the Draft Community Preservation Committee Regular Meeting Minutes from September 15, 2025.

The motion of Deb Converse was seconded by Terry Duenas to approve the September 15, 2025, CPC meeting minutes as submitted. Aye (6), No (0). The motion carried with a unanimous vote.

Letters of Intent:

• A Letter of Intent has been received from the Planning & Development Department for \$4,200 in CPA Open Space/Recreation funds for the purchase of 30 hiking trail signs to be placed at roadside trail approaches for Town of Barnstable Conservation trails pending locational safety approvals.

Ms. Alice Marcus-Kreig, Grants Coordinator and Open Space Planner, Planning and Development Department explained that the Letter of Intent represents a request from the Open Space Committee who is currently working on the Open Space and Recreation Plan. Ms. Marcus-Kreig said that the request for funds in the amount of \$4,200 is to purchase and install 30 signs to be installed by the DPW this Fall and Spring of 2026. Alice narrated a PowerPoint presentation depicting an example of the hiking sign and locations that the DPW will be installing the signs saying that placement will be 50 to

She explained that the intent is to alert people of the available assets that the Town owns and to get people out onto the trails. Signage will be provided for the Andrews property, Lumbert Pond, Crocker Neck, Joshua Pond, Santuit River, Santuit Pond, Seabury Farm, Jenkins Bridge Creek, and Trayser.

There was CPC member discussion regarding the need for trail maps for each parcel and Ms. Marcus-Kreig said that Open Space is working with GIS to create a deliverable map of trails. Chair Counsell added that they are presently working on trail head maps that would be located in the parking areas as the first phase.

The motion of Tom Lee was seconded by Katherine Garofoli to move the Letter of Intent from Planning & Development for \$4,200 in Community Preservation Open Space and Recreation Funds for the purchase of 30 trail signs to the full Application stage. Aye (6), No (0). Motion carried with a unanimous vote.

- The Barnstable Land Trust's Woodland Bog Application for CPA Open Space funds has been referred to the Town Council for public hearing on November 6, 2025.
- The Department of Public Works' Application for additional CPA Open Space/Recreation funds for the Osterville Playground Project has been referred to the Town Council for public hearing on November 6, 2025.
- Conservation Restrictions for the Harju and Prince Avenue properties are being reviewed and will be placed on an upcoming Town Council agenda for approval.
- The draft Conservation Restriction for the Mill Pond project is in progress. The project will be referred for Public Hearing at Town Council once the draft Conservation Restriction is finalized.
- The closing for Smith's Creek Conservation Restriction will be scheduled once the Land Court provides required documents.
- The Barnstable Land Trust will be closing on the Cotuit Highground project October 25, 2025.
- An updated Letter of Intent is anticipated from Oddfellow Lodge based upon the building assessment completed by the consultant. Confirmation of non-profit status is required.
- The Preservation Restriction consultant is working on the South Congregational Church Burial Ground Preservation Restriction.
- DPW Applications for the Osterville Recreation Comfort Station and Centerville Recreation Ballfield are anticipated for the November 17, 2025 CPC meeting.

Member Discussion:

 Discussion and vote to approve \$8,850 in CPA Administrative funds for the creation of a Conservation Restriction plan for 230 Old Colony Road which is the 2016 land acquisition by Cape & Islands Engineering.

The motion of Katherine Garofoli was seconded by Deb Converse to approve the use of up to \$10,000 in CPA Administrative Funds for the creation of a conservation restriction plan and recording fees for 230 Old Colony Road property owned by the Town of Barnstable. Aye (6) No (0). The motion carried with a unanimous vote.

Discussion and vote to approve \$2,000 in CPA Administrative funds for a
Conservation Restriction appraisal for 3640 Falmouth Road, Marstons Mills.
Chair Counsell explained the new requirement that CPC acquire appraisals for the
value of a conservation restriction, not the fee value.

The motion of Terry Duenas was seconded by Katherine Garofoli to approve the use of \$2000 in CPA Administrative Funds for the appraisal of the conservation restriction value for 3640 Falmouth Road, Marstons Mills. Aye (6) No (0). The motion carried with a unanimous vote.

- CPC Website Updates Chair Counsell asked members to provide input.
- It was decided that the November 17, 2025, CPC Meeting will be held remotely.
- Election of Community Preservation Committee Officers for FY 2026.

Tom Lee nominated Lindsey Counsell to continue as Chairman and Stephen Robichaud as Vice Chairman. Katherine Garofoli was nominated as Clerk. The motion of Chair Counsell was seconded by Stephen Robichaud to accept the slate of officers as nominated. Aye (6) No (0). The motion carried with a unanimous vote.

 Chair Counsell noted that he would not be seeking reappointment next June 2026 and that Stephen Robichaud will be prepared to step in as Chairman. Terry Duenas indicated that he may also not seek reappointment at that time saying that both Lindsey and he have served on the CPC for 21 years.
