### IV CERTIFICATES OF COMPLIANCE

Donna Lawson, of Long Pond Community Gardens, described the gardens as "a beautiful place." Last season, no problems were experienced. No chemicals are used.

B. Replanting cedars at Fortes Beach

The Chair provided the background to the cutting violation which occurred on Town property. Staff requested that the requirement to re-plant the cut cedars be set aside. The Town Recreation Department has removed the slash and stumps resultant from the cutting.

A motion was made to rescind the re-planting requirement.
