# IV ENFORCEMENT ORDERS

A. Richard Rakauskas – 14 Pine Lane Hyannis
Alteration of a resource area, flood zone, and alteration of the 50' undisturbed buffer and 100' buffer from a wetland, Snow's Creek, by removing of vegetation, creating lawn space, and other landscaping improvements.

A motion was made to amend the enforcement order to read that property owner shall demarcate 50-foot buffer, once located by staff, and allow it to grow back; no mowing allowed; demarcation to be done in consultation with staff; single-rail fence or approved alternative; an RDA application must be filed for work in 50' - 100' buffer, with fee of \$100; gang plank removal stricken from the enforcement order.

Seconded and approved: 6 votes = Aye, with one abstention.

B. Demetrios B. Haseotes – 312 Long Beach Rd. Centerville

Failure to request certificate of compliance. Alteration of a resource area, Centerville River, by constructing additional non-permitted pier sections. Alteration of a resource area by leaving abandoned floating boat lift aground in Centerville River channel off of Town of Barnstable Conservation area.
