Conservation Administrator, Darcy Karle was present along with Administrative Assistant Kim Cavanaugh.

I. REQUESTS FOR DETERMINATION

A. **G. Richard Kramer.** Septic system upgrade and proposed well at 342 Nyes Neck Road, Centerville as shown on Assessor's Map 232 Parcel 013. DA-21040

The applicant was represented by Daniel Ojala, P.E. of Down Cape Engineering.

Issues discussed:

- The Board of Health has approved the project.
- The cesspool will be pumped and filled in.
- The property is only used seasonally.
- It will be on Town sewer in the next 10 years.

There was no public comment.

A motion was made to approve the project as a negative determination.

B. James T. & Carol Ann Harris. Raze existing concrete structure to construct proposed pool, garage, stairs, retaining walls, and paved driveway with rain garden for storm water management at 214 Tern Lane as shown on Assessor's Map 192 Parcel 029. DA-21041

The applicant was represented by Brendan Kling of Grady Consulting, LLC.

Issues discussed:

- Most of the project is outside Conservation jurisdiction.
- The raingarden is just for storm water run-off.
- There is no pool draw down pit on the plan. A drywell should be put in for the draw down. A revised plan should be submitted.
- A revised plan was submitted which included the elevations of the retaining walls.

There was no public comment.

A motion was made to approve the project as a negative determination subject to receipt of a revised plan showing drawdown pit.

II. NOTICES OF INTENT

A. James C. & Kathleen C. Henry. Proposed installation of a new "T" shape residential seasonal dock located at 15 Piney Point Drive, Centerville as shown on Assessor's Map 228 Parcel 155. SE3-5902

The applicant was represented by Brian Wallace of JC Engineering Inc.

Issues discussed:

- The NHESP comment letter has not come in.
- There are rare plant species that triggered the NHESP filing.
- There have been projects approved in the area prior to this filing.
- The kayak rack should be put on the plan. Boats and kayaks should be stored in the rack.

There was no public comment.

A continuance was requested to August 17th for receipt of the NHESP comment letter.

A motion was made to approve the project subject to receipt of a revised plan showing the kayak rack and continued solely for receipt of the NHESP letter and comments.

B. **Anne Seminara.** Construct a single family dwelling, Title 5 septic system, landscaping and inground pool at 52 Meadow Farm Road, Centerville as shown on Assessor's Map 188 Parcel 175. **SE3-5901**

The applicant was represented by Daniel Ojala, P.E. of Down Cape Engineering.

Issues discussed:

- Revised plan date is 7/26/21. Wetland flagging information is still needed and the data sheets. The name and date should be added to the plan.
- The location of the mechanical equipment will be outside Conservation jurisdiction.
- The slope at the bottom of the property will be used to create a swale at the bottom. Erosion control netting and hydro-seed will be used.
- The drywell to the west will be utilized for the backwash pit.
- There should be demarcation of the work limit line. Large stones could be put along the work limit line.

There was no public comment.

A motion was made to approve the project subject to receipt of a revised plan showing the wetlands flagging information and demarcation of the work limit line.
