## II. REQUESTS FOR DETERMINATION

**A. Town of Barnstable Recreation Department.** To install Mobi Mats at Sea Street Beach for better accessibility at 465 Sea Street, Hyannis as shown on Assessor's Map 306 Parcel 191. **DA-24030** 

The applicant was represented by John Gleason, Barnstable DPW

Issues discussed:

- The area is just sand at this time.
- The mats will be removed seasonally.
- There should be an ongoing condition for seasonal installation after three years.
- Staff supports the project.
- Someone will need to be responsible to make sure sand does not cover the mats after a storm.
- The mats should be left in place during the shoulder season.
- They will be put in in May and taken out around Columbus Day.
- The mats are 5' wide and 50' long. There will 200' of mat.

### Public comment:

Patty Ericson-Tayor, 130 Sea Street, Hyannis - She became disabled in 2021. This will help her get onto the beach. Her goal is to get every beach on the cape accessible.

Paul Logan - Chair of Barnstable Disability Commission. This will help a lot of people. The mats are invaluable to get onto the beach. The Town also has Mobi Chairs available to people to get into the water. It would be helpful to be able to put these in and out without having to go through the permit process annually.

A motion was made to approve the project as a negative determination, subject to it being seasonal use, and the Determination may continue on into perpetuity.

- The native plantings will be better than what is there now.
- Only 186 sq. ft. of mitigation was required but they are putting in 11,050 sq. ft.
- A continuance is needed for issuance of the DEP Number.
- A continuance was requested to July 16, 2024.
