Director of Golf Maintenance Report – McIntyre

Bruce gave a report for Chris who could not attend the meeting this evening. The winter work is going as scheduled the entire staff is at Olde Barnstable pruning. We were also able to get the last spray down.

Director of Golf Report Capital Improvement Plan – Mcintyre

Bruce wished everyone a happy new year. The mailer went out for annual pass renewals and we will be doing the early sign up raffle ending February 28th. The annual CIP meeting and decision packages went well, there were a few large increases mainly due to retirement and personnel costs. Budget narratives are due to town hall next week. The HVAC unit at Hyannis has failed and we are putting together an emergency purchase for the restaurant. In other news NSTAR (eversource) will be adding additional poles for new power lines that will be coming through the area the next few years. Keith asked about the CIP and if there would be a bond for some or all the potential cart path product. Bruce explained the bond could be done a few ways. John Cookson asked who the main decision makers are.

Fred Parker asked Bruce if Mark Milne would be able to attend the March 12th meeting. Bruce said that he would ask.

Financial Report - Beauchamp

Nancy gave a brief summary of the numbers year to date. Some highlights are the overall rounds being up; pro shop sales at Hyannis have hit a very high \$118K for the first six months which is already at 82% of budget. The average ticket at Hyannis is also at \$6 which is very good.

Fred went over some historical questions with Bruce about the Hyannis Golf Course and the process we have been through over the years.
