Acting Chair Laurie Young called the meeting to order at 4:10pm

*Acting under the provisions of the Code of the Town of Barnstable, ss 112-1 through 112-7, the Historical Commission held a Public Hearing on the following application:*

**The following Applications were determined significant and referred to Public Hearing:**

**Beyer, Eric & Young-Beyer, Patricia, 418 South Main Street, Centerville, Map 207, Parcel 008**

Built c.1890, Inventoried, Not in a National Register Historic District

Exterior Alterations

Represented by Steve Cook, Cotuit Bay Design, LLC

Mr. Cook detailed the project which includes the construction of a new chimney. This will require the relocation of two windows to be placed on either side of the chimney. The chimney will have a herringbone pattern and a nice design on top with chimney pots. Nancy Clark inquired about the two windows on the right elevation identified on drawing A2 and Steve Cook stated that these windows will be replaced with French doors or perhaps even an older looking door. Nancy Shoemaker confirmed that the windows would not be replaced with sliding doors. Nancy Clark commented that the porch which was replaced last year looks great.

**Motion duly made by Nancy Clark, seconded by Nancy Shoemaker, that the Historical Commission finds, after review and consideration of public testimony, application and record file for partial demolition proposed for the single family home proposed at 418 South Main Street, Centerville, that the structure to be partially demolished is not a preferably preserved significant portion of the building.**

**So Voted Unanimously (Young, Fifield, Clark, Shoemaker)**

**Motion duly made by Nancy Clark, seconded by Nancy Shoemaker, that in accordance with Chapter 112F the Historical Commission determines that the partial demolition proposed for the single family home located at 418 South Main Street, Centerville would not be detrimental to the historical, cultural or architectural heritage or resource of the Town.**

**McPherson, Susan, 38 Hawthorne Avenue, Hyannis, Map 286, Parcel 008**

Built 1908, Not Inventoried, Contributing Building in Hyannis Port National Register Historic District

Remove Existing Foundation, Walkout Walls, Window

Represented by Steve Cook, Cotuit Bay Design, LLC

Steve Cook explained that this is a typical summer house with no basement. They propose to remove the foundation and walkout walls as the house is in the new flood zone. They plan to lift the building, pour a new foundation on the north elevation and partial foundation on the west and east elevations. The new slab will be above the flood area and a new patio is proposed. The main part of the building will remain intact. Nancy Clark asked what is proposed to cover the new cement foundation and Steve Cook confirmed wooden shakes on the walkout side and on the east, south & west elevations, there will be shingles, same as what is there now. The proposed two double slider doors may become a French door.

Chair Young reminded the members that the property is a contributing building within the Hyannis Port National Register Historic District, requiring this Commission to make a determination on if this is a substantial alteration. If so, a referral to the Cape Cod Commission would be necessary.

Nancy Clark asked if the new proposed doors are sliding doors and Steve Cook replied that they are. Currently, the 2<sup>nd</sup> story windows are sliding windows. George Jessop asked if it was necessary to take off the buttresses as they are a unique defining feature of the building and one worth saving. It would not make the sliding doors proposed any less usable. He also asked how much the building will be raised for the new foundation and Steve Cook stated approximately one foot to eighteen inches.

Nancy Clark concurred that if the buttresses remain, she believes this would not be a substantial alteration. Steve Cook conferred with the homeowner who was present, and they agreed to keep the buttresses and he requested a continuation so that he could revise the proposed plans.

**Motion duly made by Nancy Clark, seconded by Marilyn Fifield, to continue the application of Susan McPherson at 38 Hawthorne Avenue, Hyannis to the October 21, 2014 hearing to be held at 4:30pm for modification to plans.**
