Applicant requested to substitute stone set in the proposed concrete base and the Commission recommended mortar joints. Tables and Chairs are steel expanded metal top in black with powder coated finish.

Motion duly made by Dave Colombo, seconded by Dave Dumont to Approve the Certificate of Appropriateness as amended to reflect substitution of stone with mortar joints for patio, fencing and planters to contain colonial caps on elevated posts and lighting fixtures in black.
