Members Present: George Jessop – Chair, Paul Arnold – Vice Chair, and Dave Colombo

Staff Present: Karen Herrand, Principal Assistant, Growth Management Dept.

A quorum was not met. The meeting started at 7:00 p.m. (members were waiting for a fourth member, William Cronin to possibly show up in order to have a quorum).

Chair George Jessop and Vice Chair Paul Arnold explain that the Board Members cannot vote on the applications presented tonight, but can review/make recommendations. Some discussion regarding the Mullin in rule.

An announcement was made by Chair Jessop stating the meeting is being recorded and broadcast on Channel 18 and in accordance with MGL Chapter 30A, §20; and requested that anyone taping this meeting to please make their presence known.

New Business

Carlos Barbosa - d/b/a Clau's Beauty Salon & Spa – 330 Main Street, Hyannis, Map 327/Parcel 092
New Business Sign

Carlos Barbosa in attendance.

Chair George Jessop states that he has some concern regarding the mounting in the brick work. Reference is made to Exhibit A (copy of the sign).

Paul Arnold confirms the color of the signage to be black and salmon with a white background.

Dave Colombo asks about aluminum as opposed to pvc? How will it be fastened?

Chair Jessop explains the mounting with the aluminum, which holds the paint and prevents moisture from getting behind it.

HOLD MOTION: Paul Arnold makes a motion to approve this sign application as presented, Dave Colombo seconds the motion.

Dave Colombo directs to Michael Gaggiano, of Plymouth Sign Co., (in attendance for other signage) and asks for an expert opinion regarding the aluminum signage vs. wood?

Michael Gaggiano explains that the aluminum has more of a gloss than the pvc, which is more satin. With a trim coat around it, it will not fade, moisture won't get into it.

Maria Medeiros - d/b/a Chantilly's Bridal – 342 Main Street, Hyannis, Map 327/Parcel 006-001

Two New Business Signs

Michael Gaggiano of Plymouth Sign Co. in attendance. He explains the proposed signage. The letters will be black on a flat surface, 3/4 inch thickness. Series of panels divided. Reference to Exhibit B (picture of signage). White background.

Chair George Jessop would like to see it centered in the 3 panels, which are divided, reference to Exhibit C (second sign).

Dave Colombo clarifies that the sign on main street is a flat surface?

Michael Gaggiano answers yes, and they will not be increasing in size.

Dave Colombo comments that the business downstairs may look like it's representing Chantilly's Bridal from this sign.

HOLD MOTION: Dave Colombo makes a motion to accept the application as presented, seconded by Paul Arnold.

Hyannis Area Chamber of Commerce – 356 South Street, Hyannis, Map 308/Parcel 099

One New Business Sign

Michael Gaggiano of Plymouth Sign Co. in attendance. This will be a 12 sq. ft. sign, 3 ft. by 4 ft. inside of the fence, closer to the entrance. Plywood with primer and blue vinyl lettering, 2 posts, one on each side, with colonial fence posts/caps in vinyl. Reference is made to picture of sign (Exhibit D).

Dave Colombo recommends maybe putting in an aluminum cap at the top which may prolong the life of the sign.

HOLD MOTION: Paul Arnold makes motion to approve this application as presented, seconded by Dave Colombo.

Dave Colombo points out the first sign application (Clau's Beauty Salon & Spa) pg. 2, lists an open/closed sign (Exhibit E, Claus Spa Application) checked off as applying for 3 x 5 red and blue, flag size.

Paul Arnold asks that staff clarify with the applicant as to what is being requested, flag or sign.

Other Business

Paul Arnold asks when will we hear about some type of enforcement? Does the Commission need to ask for a reply?

HOLD MOTION: Dave Colombo asks that we ask for a reply regarding the letter from Chair Jessop to Tom Perry, Bldg. Commission dated February 11, 2015, seconded by Paul Arnold.

Discussion regarding a possible Mullin in procedure for this meeting and rules regarding a quorum.

Discussion regarding a new permanent member for the Commission, possibly the Alternate Taryn Thoman. A letter needs to be drafted to Town Council regarding this.

Discussion regarding the need to replace/new Clerk. There is a vacancy now that Joe Cotellessa has passed. The Commission will ask one of the other members to move up to Clerk. Some discussion that Bill Cronin be nominated for this position.

The meeting adjourned at 7:34 p.m.
