# 1. Amend Live Entertainment License

An application has been filed Venditti Enterprises, Inc. dba *Mattakeese Wharf Restaurant*, 271 Mill Way, Barnstable, to amend the live entertainment license <u>From</u>: 1 pianist daily from 5pm-12:45am. <u>To</u>: 1-3 piece amplified band. Amended entertainment hours are Fridays, 6:00 p.m. to 9:00 p.m.; Saturday 7:00 p.m. to 10:00 p.m. and Sunday 5:00 p.m. to 9:00 p.m.

# 2. Amend Live Entertainment License

An application has been filed Warren T. Baxter, Inc. dba **Baxter's Boathouse Club, Inc.**, 177 Pleasant Street, Hyannis, to amend the live entertainment license <u>From</u>: Daily live, amplified, music up to 3 performers, inside only on Thursday, Friday & Saturdays from 7pm – 12:45am, and Sundays 3pm to 8pm <u>To</u>: Fridays 5pm-7pm, live amplified music outside, for a single guitar player and Sundays 3pm-7pm, live amplified music, outside, for one vocalist.

### 4. Amend All Alcohol Common Victualler License – Change of Manager

An application has been filed Not Your Average Joe's, Inc. dba **Not Your Average Joe's**, 793 Iyannough Road, Hyannis, to amend the alcohol manager from David Hamill to Moriah Belle Bassett.

Cape Cod Beer is pending review of the outdoor dining expansion by the Site Plan Review Committee on July 23, 2024. Should the plan be approved by the committee, the Licensing Authority will be charged with acting on item 5A below and item 5B will be withdrawn by the applicant. Should the Site Plan Review Committee find that there are items that need to be addressed prior to moving forward with the permanent change to the outdoor dining plan, the Licensing Authority will be asked to consider acting on item 5B and continue item 5A to a date uncertain.

#### 5A. Amend Farmery Brewery Pouring License - Outdoor Dining Expansion

It is possible that if it so votes, the sub-committee may go into executive session. For your information the section of the M.G.L. that pertains to postings of meetings is as follows: Except in an emergency, in addition to any notice otherwise required by law, a public body shall post notice of every meeting at least 48 hours prior to such meeting, excluding Saturdays, Sundays and legal holidays. In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours
