BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES

Town Hall Building, 367 Main Street, 2nd Floor Hearing Room, Hyannis, MA – 9:30 a.m. January 31, 2011

A regular meeting of the Barnstable Licensing Authority was held on Monday, January 31, 2011. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Thomas Geiler, Director of Regulatory Services and Licensing Agent, Lt. JoEllen Jason and Ptl. Steve Maher, Liaison Officers from the Barnstable Police Department, and Christine Ade, Recording Secretary.

Hearings:

New Daily Non-Live Entertainment and Video Games License: Application of Tri Corps Entertainment Inc., 5 Veronica Avenue, Somerset, NJ, for 7 video games at the Regal Cape Cod Cinemas 12, Cape Cod Mall, Hyannis, MA for a Daily Non-Live Entertainment License and Video Games License. These licenses were previously held by the cinema itself. It is for the same number of games, in the same place as previously located.

Dave Martin appeared for the application of Tri Corps Entertainment, Inc. They have taken over the games from the cinema itself. Nothing else has changed.

A motion was duly made by Gene Burman, seconded by Paul Sullivan and a unanimous vote taken to approve the application of Tri Corps Entertainment Inc., 5 Veronica Avenue, Somerset, NJ, for 7 video games at the Regal Cape Cod Cinemas 12, Cape Cod Mall, Hyannis, MA for a Daily Non-Live Entertainment License and Video Games License. These licenses were previously held by the cinema itself. It is for the same number of games, in the same place as previously located.

<u>New Location – Junk Dealer License:</u> Application of Cape Abilities, Maggi Tyson, Manager, for a change of location of its Annual Junk Dealer License from 3284 Route 6A to 3239 Main Street, Barnstable, MA (continued from 1/10/11).

Andrew Todoroff appeared for this application. They have relocated down the street to 3239 Main Street, Route 6A, Barnstable. Mr. Hoxie asked the distance between the two, and was told by Andrew that it is about a 3 wood.

A motion was duly made by Gene Burman, seconded by Paul Sullivan and a unanimous vote taken to approve the application of Cape Abilities, Maggi Tyson, Manager, for a change of location of its Annual Junk Dealer License from 3284 Route 6A to 3239 Main Street, Barnstable, MA. Maggi Tyson is still the Manager.

<u>Change of d/b/a:</u> Request of H&S Entertainment, LLC, d/b/a Sally & Harry's, 350 Stevens Street, Hyannis, Constantinos Mitrokostas, Manager, for a change of d/b/a to Dina's.

Constantinos Mitrokostas appeared for his application. He said that the purpose of this application is merely to change the d/b/a of the business to Dina's. He stated that he wants the name change to correlate it with Dino's in Mashpee and for personal preference to keep them separate from "Harry's" as the previously requested name had as part of it the Harry's name. He said it has been well received. They do have the Common Victualler license recently approved and final Building inspection this week with training; opening next week. It will be all waitress service, lots of T.V.'s, restaurant focused on women to make it a "sister" restaurant to Dino's. Mr. Geiler stated we might want to take this request under advisement as any more complications at the ABCC since it is not already approved might delay it further. Mr. Mitrokostas stated it is an administrative fix at the ABCC, and there is no fee at that level – they just need to be notified of the name change. Mr. Geiler stated we can continue it to the next meeting without further testimony. Mr. Hoxie agreed. Once the Board is advised the application is back we can then approve it. Mr. Mitrokostas disapproved of that but it was brought up that any approval must be mailed up to the ABCC within 3 days.

A motion was duly made by Gene Burman, seconded by Paul Sullivan and a unanimous vote taken to continue the application of H&S Entertainment, LLC, d/b/a Sally & Harry's, 350 Stevens Street, Hyannis, Constantinos Mitrokostas, Manager, for a change of d/b/a to Dina's to its next hearing without the need of reappearance of the applicant before the Board to be approved as soon as the ABCC approval comes down.

Business Meeting:

Ptl. Maher advised that there is still a problem with Goldfinger with regard to compliance with the Rules and Regulations for Junk Dealer Licenses so he is requesting a Show Cause Hearing be held at the March 14th meeting.

The meeting was adjourned at 9:40 a.m	. until the February 14 th meeting.
