Typically 5 days with 2 to serve.

After testimony from Consumer Affairs Officer Therese Gallant and statements made by your attorney, the following motions were voted by the Licensing Authority:

ACTION: To move that the Licensing Authority suspend the Annual Wine and Malt Package Store license for 5 days: of which you will serve a 2 day suspension on January 7 and 8, 2019 and have 3 days suspension held in abeyance for 2 years from the date of this hearing. The grocery store/market may be open during the suspension.(3-0)

ACTION*:* To move that the Licensing Authority suspend the Annual All Alcohol Package Store license for 2 days: of which you will serve one day suspension on January 15, 2019 and have one day suspension held in abeyance for two years from date of this hearing (2-1)

Licensing Division Updates:

- 1. Licensing Department updates- Seasonal population increases will be done by the Town Clerks office. Two locations regarding the lemon law, Balise and Hyannis Honda had less than 100% compliance. Motion that we send a letter to both entities. Periodic inspections; possible show cause. Board of Health smoking policy was distributed.
- 2. Police Department updates- Ten Pin Eatery altercation on Halloween, 3 criminal charges were given. The Ten Pin Eatery management was extremely helpful. The security systems have paid dividends. Expressed frustration with the compliance checks process, vow to do better in 2019. Lt. Murphy wants to meet with the ABCC. Additionally, not do these tests over 2 days, are they valid? Compliance checks take place over the entire year; advertise accordingly.
