## **New Business:**

1. Application of a One Day Extension of Licensed Premise for an Annual All Alcohol Common Victualler License: Application of Jillian Manning on behalf of Cape Cod Coffee for a One Day Extension of Licensed premise for the E for All Showcase event. The extension includes the Terminal/Foyer at the Barnstable Municipal Airport. The floorplan was approved by the Building Commissioner on 11/27/18. The event will take place at Cape Cod Coffee, 480 Barnstable Rd., Hyannis on January 10, 2019 from 6:30 to 8:30 PM.

Mr. Scali commented on the last drink report from the Attorney General's office. He will send notices to all referenced establishments in addition to the Commissioners. Mr. Hoxie asked what action can be taken. Other municipalities have written letters or brought them in to speak to the Board according to Mr. Scali.
- **2. Police Department updates-** Lt. Murphy stated that it is important that letters are sent to these establishments. 1) The ABCC was on Cape this

Friday; Tiki-Port was issued a violation for serving a minor. 2) Looking to expand the Alcohol, Compliance to a yearlong program. The Young Adults have to take some responsibility in this; specifically with fake ID's. 3) In early 2019, need to speak with second hand dealers about gift card resale as this is a result of increased shoplifting.

Mr. Semprini asked about any progress with the NIP problem. Lt. Murphy stated that Chelsea passed but the ABCC did not uphold. There is discussion of adding a \$.05 deposit. Also, what is the status of the needle exchange in Hyannis? Lt. Murphy stated this is a statewide problem due to deregulation; he has no negative or positive information to report at this time.
