Public Hearings

1. New - Annual All Alcohol Common Victualler And Live/Non-Live Entertainment Licenses
Application by Massachusetts Military Support Foundation, d/b/a Gimmy's Tavern, 1800
Iyannough Road, Hyannis, Don Cox, Manager, for a new Annual All Alcohol Common
Victualler, and Live and Non-Live Entertainment Licenses. Daily hours of operations are from
9:00AM-12:00AM, and entertainment to include dancing by patrons and live music up to 3
performers/pieces, recorded music and four TVs. Description of premise as follows: Wood
frame structure consisting of dining room approximately 1500 sq. ft., kitchen area,
restrooms, storage and holes 1-18 on golf course inclusive of cart path. Exits: front
door, multiple exits to rear deck, 2 stairways to ground snack bar on lower level with
inside and outside service. Seating Capacity for 120.

Application represented by Don Cox, President and Chief Operating Officer of Mass Military Support Foundation. Mr. Cox stated that Live Entertainment will primarily be reserved for private functions; considering having a pianist or guitarist perform for members on an occasional basis. Mr. Cox further stated that the lease agreement is valid for three years with a two year and five year option for renewal.

2. <u>Alteration Of Premise - Annual All Alcohol Common Victualler License</u>
Application by Colombo's Café & Pastries Inc., d/b/a *Colombo's Café and Pastries*, 544 Main Street, Hyannis for an alteration of premises, to add the following area to the existing description: seasonal, outside patio bar and food service area with 18 new seats comprised of an at-grade patio, a bar, 10 bar seats, 4 tables, 8 table seats, a railing enclosure, lighting and an awning covering.

Application represented by Attorney Dan Creedon and Dave Colombo. The intent of the proposal is to utilize two seating plan configurations. The existing approved seating plan will be utilized in the off season. The alternative plan includes a newly created outdoor patio space with seating for 18 and an indoor live performance area to be used during the summer season.

Application represented by Jessica Wilson.

Cotuit Resident and Disability Committee Member, Paul Logan asked for the number of handicap parking spaces at the establishment and noted that a portion of the access isle is located on a ramp and thus does not meet the legal requirements for an acceptable access isle. Ms. Wilson stated that two handicap spaces are located adjacent to the ramp and the lot being restriped. Director Hartsgrove stated that a complete parking plan of the lot is on file with the Building Department which shows the number of spaces allocated to each business.
